**MOTION FOR LEAVE TO FILE SUPPLEMENT TO OPPOSITION TO PETITION TO  
DENY AND REVOKE**

Multicultural Radio Broadcasting Licensee LLC “(Multicultural)”, by its counsel, hereby requests leave to submit this Supplement in response to a new issue set forth in the Reply to Opposition to Petition to Deny and Revoke (“Reply”) filed by the Ukrainian Congress Committee of America, Inc. (“UCCA”) on May 18, 2022. In its Reply, UCCA claims that Multicultural failed to provide an affidavit in support of certain factual statements included in its Opposition pleading in violation of Section 309(d)(1) of the Communications Act. Those statements of fact related to the issues programs lists of Station WZHF(AM).

1. Attached is the Affidavit of Arnold Ferolito, the Manager of RM Broadcasting LLC, which is the programmer of WZHF. He states that he has personal knowledge of the facts set forth in the Issues/Programs List that was provided in Multicultural's Opposition pleading. This Affidavit was inadvertently missing from the Opposition and Multicultural respectfully requests acceptance of this Affidavit as part of the attached Supplement.

2. Please note that in its Petition to Deny and Revoke, UCCA relied on the WZHF 4<sup>th</sup> Quarter Issues/Programs List to make its argument that Station WZHF, licensed to Capital Heights, Maryland, is airing Russian propaganda.<sup>2</sup> However, UCCA failed to provide an affidavit from someone with personal knowledge that Station WZHF was indeed airing Russian programming and the basis for such factual information. Coincidentally this is what UCCA is accusing Multicultural of failing to provide. The only Affidavit provided by UCCA is from someone who states he is a regular listener of the six (6) stations listed in the heading to this pleading. That person is not a listener of WZHF. Furthermore, it is now clear that this individual does not even speak any of the languages aired on the six (6) stations. So not only does the UCCA Petition fail to satisfy standing, it also fails to support its factual assertions with an affidavit.

3. UCCA complains that the footnotes in Multicultural's Opposition were not in 12 point height. In order to make these footnotes more legible, Multicultural submits the Supplement with the footnotes in 12 point height. Multicultural respectfully requests acceptance of the Supplement for this purpose.

**SUPPLEMENT TO OPPOSITION TO PETITION TO DENY AND REVOKE**

Multicultural Radio Broadcasting Licensee, LLC (“Multicultural”), by its counsel, hereby opposes the Petition to Deny and Revoke (“Petition”)<sup>1</sup> filed by Ukrainian Congress Committee of America, Inc. (“UCCA”) against the above-captioned radio station licenses.<sup>2</sup> UCCA claims that Station WZHF(AM), Capitol Heights, Maryland (Facility ID No. 73306), licensed to Way Broadcasting Licensee, LLC, is airing Russian propaganda and that the FCC should revoke WZHF’s license as well as the licenses for all of the stations with common ownership. However, Section 326 of the Communications Act of 1934 as amended<sup>3</sup> and the First Amendment of the U.S. Constitution prohibits government censorship. Moreover, Section 309(k)(1) of the

Communications Act of 1934, as amended<sup>4</sup> forbids the Commission from attributing violations of one station to any other stations owned by or affiliated with the same licensee. UCCA fails to justify having the Commission even consider revoking the licenses. For these reasons, the Petition must be denied and dismissed.

**I. THE PETITION IS OVERBROAD AND FAILS TO MEET ITS THRESHOLD BURDEN**

1. UCCA fails to meet its threshold burden for the above referenced New York and New Jersey stations. UCCA includes a Declaration from Andrew Barak and states that Mr. Barak is a regular listener of these stations. However, each of these stations program in foreign languages:

Mandarin (WKDM);

Cantonese (WZRC);

Korean (WWRU);

Spanish (WTTM, WPAT and WHWH).<sup>5</sup>

Mr. Barak does not indicate that he is fluent in any of these languages.

2. Section 309(d)(1) of the Act requires that a petition against a license must present specific allegations of fact that are supported by an affidavit from a person with personal knowledge of those facts.<sup>6</sup> UCCA presents a litany of purported “Russian lies and propaganda” it claims were broadcast on Station WZHF only.<sup>7</sup> UCCA does not claim that any of the 6 stations that it opposes for renewal carries this type of programming. Furthermore, the Petition fails to

meet Section 309(d)(1)'s specificity threshold, as it does not provide dates or quotes of the alleged false programming, nor does it present any evidence (beyond assertions of its own opinion) to prove the inaccuracy of the information or any knowledge of the owners of the licensee that such information was false. The sole Declaration supplied with the Petition is neither dated, nor does it state with particularity whether the Declarant, Andrew Barak, heard the specific "lies" allegedly aired on WZHF.<sup>8</sup> UCCA failed to satisfy this most basic evidentiary threshold, and thus the Petition must be dismissed or denied.

3. Furthermore, Section 309(k)(1) provides that "if a licensee of a broadcast station submits an application to the Commission for renewal of such license, the Commission shall grant the application if it finds, **with respect to that station**, during the preceding term of its license---

- (a) the **station** has served the public interest, convenience and necessity;
- (b) there have been no serious violations by the licensee of this chapter or the rules and regulations of the Commission; and
- (c) there have been no other serious violations by the licensee of this chapter or the rules and regulations of the Commission which, taken together, would constitute a pattern of abuse." (Emphasis added)

UCCA has not shown or even alleged any violations by the stations that are at issue in this proceeding.

4. Knowing that Section 309(k)(1) does not allow allegations of violations to be considered if they do not involve the stations in question, UCCA nevertheless argues that the

alleged violations committed by Station WZHF, licensed to Way Broadcasting Licensee, LLC, are so egregious that any stations with similar ownership must be subject to revocation as well.

5. The Petition's allegations pertain *only* to programming aired on Station WZHF. The Multicultural stations listed in the caption did not air any of the programming at issue in the Petition. UCCA fails to cite any case in which the Commission denied a station's license renewal application based on another station's alleged violations.<sup>9</sup> Because the Petition fails to identify any violations by the listed Multicultural stations, the Petition must be denied and dismissed.

## **II. THE PROGRAMMING AT ISSUE IS LEGITIMATE INFORMATION AND OPINION, AND IS PROTECTED BY THE FIRST AMENDMENT**

6. In support of its position that the owners of these stations are unfit as licensees, UCCA only points to one program segment listed in the 4<sup>th</sup> Quarter of WZHF's 2021 Issues Program list. That program featured an interview with an individual who is described as an international affairs and security analyst and who voiced his views on the reasons Russia engaged in a war with Ukraine. UCCA fails to mention that none of the other 55 programs identified in that same quarterly issues programs list involves the war in Ukraine. Rather the topics range from high prescription drug prices, the impact that COVID-19 has had on the labor market in various industries, the topic of critical race theory to events taking place in various other countries.<sup>10</sup> The guest speakers come from a variety of backgrounds. The programming is clearly not a Kremlin based propaganda outlet as suggested by UCCA. The programs are

produced in the United States, by journalists and broadcast professionals who, to Licensee's knowledge, are largely American citizens.

7. The programs airing on WZHF Monday-Friday for 2 hours included discussions on: (1) race and capitalism, with guest Dr. Charisse Burden-Stelly, Assistant Professor of Africana Studies and Political Science at Carleton College, and Visiting Scholar with the Race and Capitalism Project at the University of Chicago; (2) a proposal for New York City police to use autonomous drones to monitor crime, with guest technologist Chris Garaffa, the editor of TechforthePeople.org and co-host of the ReBoot podcast; and (3) the sharp rise in South Korean COVID-19 cases and why South Korea's "living with COVID" strategy has contributed to the recent outbreak, with guest Jia Hong from the group Nodutdol for Korean Community Development.<sup>11</sup> Recent episodes of the Monday-Friday "Political Misfits" program included discussions with: (1) Jon Jeter, author and two-time Pulitzer Prize finalist and former *Washington Post* bureau chief, about President Biden's new proposed wealth tax and the conversation we should be having about taxation in the United States; (2) Guy McPherson, scientist and Professor Emeritus of Natural Resources and Ecology and Evolutionary Biology at the University of Arizona, about clean energy storage and the White House budget's implications for addressing climate change; and (3) Kimberly Dvorak, investigative journalist and political analyst covering foreign policy, about the split in the Republican Party between anti-war conservatives and neoconservatives.<sup>12</sup>

8. The breadth of topics and information about guests appearing on WZHF's programs is detailed in the Issues and Programs Lists uploaded quarterly to WZHF's Online

Public File.<sup>13</sup> Moreover, unlike other broadcast stations around the United States that air programming furnished or paid for by foreign governments that only recently became subject to broader foreign sponsorship identification requirements,<sup>14</sup> WZHF has since 2017 aired at the top of every hour of Sputnik Radio programming a clear disclaimer identifying the source of programming – as required by the Foreign Agents Registration Act (“FARA”)<sup>15</sup> and the FCC’s general broadcast programming sponsorship identification rules.<sup>16</sup> Contrary to UCCA’s assertions that the programming aired on WZHF does not serve the public interest, there is a wealth of programming of interest to the needs and interests of the residents of the Washington DC market.

9. The FCC’s own public-facing guide to broadcast rules and regulations explains that:

The Constitution’s protection of free speech includes programming that may be objectionable to many viewers or listeners. Therefore, *the FCC cannot prevent the broadcast of any particular point of view*. In this regard, the Commission has observed that “the *public interest is best served by permitting free expression of views*.”<sup>17</sup>

This posture was reaffirmed in an April 6, 2020 decision co-signed by the Chief of the FCC's Media Bureau and the FCC's General Counsel:

[S]ection 326 of the Communications Act, reflecting First Amendment values, prohibits the Commission from interfering with freedom of the press or censoring broadcast communications. Accordingly, the Commission has recognized that '*[b]roadcasters – not the FCC or any other government agency – are responsible for selecting the material they air*' and that '*our role in overseeing program content is very limited.*'<sup>18</sup>

Courts acknowledge very limited exceptions to this doctrine, one of which is the labeling required for programming provided by registered foreign agents to ensure transparency.<sup>19</sup> As discussed above, Licensees endeavored throughout the time periods in question to ensure that Radio Sputnik's programming on WZHF complied with all FARA and the FCC's requirements so that their listeners may make an informed decision as to whether to listen or turn the dial.

10. This is not the first time that WZHF's programming has come under scrutiny. As before, there is no basis for this scrutiny. In 2018, then-Chairman Ajit Pai opened an investigation of Way and WZHF in response to the request of members of Congress that the Commission enforce the public interest standard against stations that broadcast Radio Sputnik out of concern that the programming was related to Russian government interference in the 2016 election.<sup>20</sup> In 2020, the FCC's Enforcement Bureau resolved this "extensive inquiry into the matter," which included "issuing several letters of inquiry to the licensees that broadcasted

[Sputnik Radio] programming . . . .”<sup>21</sup> The Enforcement Bureau determined that under “the [ ] Act, the Commission’s rules, and judicial precedent, there is no enforcement action that could be taken against the licensees in question.”<sup>22</sup>

11. Russia’s recent invasion of Ukraine and UCCA’s dislike of programming that may present an alternative, or even anti-Ukrainian, point of view does not alter the fact that:

Under the Constitution and the [ ] Act, *broadcast stations have broad discretion to decide what programming to air on their stations*. Absent very narrow circumstances, the government cannot and should not investigate stations or revoke licenses based on programming the station airs.<sup>23</sup>

Licensees, exercising the discretion granted to them, believe that the programming aired on each of their stations is responsive to the needs and interests of their stations’ communities. The Washington, DC market is an international community comprised of highly intelligent, sophisticated listeners of all manner of news-talk formats spanning from Christian conservative to National Public Radio. Way believes that WZHF’s programming is high-quality news and opinion that appeals to the discerning audience of the market. UCCA failed to demonstrate otherwise. Thus, the Commission must deny the Petition.

### III. PETITION FAILS TO MEET BURDENS FOR COMMISSION ACTION

12. A petition to deny or revoke a license must include specific allegations of fact sufficient to show that the continued licensing would be *prima facie* inconsistent with the public interest.<sup>24</sup> UCCA failed to satisfy its burdens.

13. UCCA cites a few cases which are unrelated to the issues in this case. In *Simmons v FCC*, 169 F.2d 670 (D.C. Cir. 1948), cert denied, 335 U.S. 846 (1948), the case involved two mutually exclusive applications for a power increase. The Court upheld the FCC's determination which was in part based on the amount of programming offered by one of the two stations but not its content. The Court indicated that by doing so it was not censoring the programming. Similarly in *Nondiscrimination in Employment Practices*, 13 FCC 2d 766 (1968) which was a rule making proceeding, there was no programming or First Amendment issues involved. The proceeding was strictly related to discrimination practices rather than censorship of programming. Finally in *Serafyn v. FCC*, 149 F.3d 1213 (D.C. Cir 1998) and *Hunger in America*, 20 F.C.C. 2d 143 (1969), Petitioner's primary argument is that the Commission should revoke the licenses for violation of the FCC's news distortion policy.<sup>25</sup> This rarely invoked and uncodified policy grants the Commission the ability to find that a station's license is contrary to the public interest where a licensee engaged in deliberate distortion or "staging" of news.<sup>26</sup> In evaluating a news distortion allegation for purposes of a public interest analysis, the Commission must analyze "both the 'substantiality' and the 'materiality' of the allegation."<sup>27</sup> A news distortion allegation is deemed "substantial" only if evidence demonstrates a deliberate attempt by the licensee to slant news or mislead the public about a significant event.<sup>28</sup> The allegation is "material" only if petitioner shows that the licensee participated in, directed, or knew of a pattern of news distortion in the programming.<sup>29</sup> Further, due to the limitations imposed on the FCC by

the First Amendment and Section 326 of the Act, the Commission requires news distortion allegations be supported by extrinsic evidence sufficient to satisfy the substantiality and materiality tests.<sup>30</sup> Petitioner failed to supply such evidence, and therefore the Petition must be denied.

14. Finally, UCCA argues that “when a radio station promotes antisocial or dangerous behavior, the FCC has the power to step in and punish the miscreant licensee.”<sup>31</sup> UCCA cites broadcasters’ obligations to ascertain, before airing, whether any programming content would be physically harmful to their listeners based on their role as “public trustees.”<sup>32</sup> While “a broadcast license is a public trust subject to the termination for breach of duty,”<sup>33</sup> UCCA failed to support its implication that the programming at issue here is causing actual harm to its listeners.<sup>34</sup> Accordingly, UCCA failed to demonstrate that Licensees breached any of their duties as public trustees and the Petition must be denied.

## **DECLARATION OF ARNOLD FEROLITO**

I, Arnold Ferolito, hereby attest to the following:

1. I am making this Declaration voluntarily and without compensation.
2. I have personal knowledge of the facts set forth herein.
3. I am the sole owner and manager of RM Broadcasting, LLC.
4. Pursuant to a contract with Way Broadcasting, Inc. (the "Programming Agreement"), RM Broadcasting provides the programming of Sputnik Radio for broadcast over WZHF(AM), Capitol Heights, Maryland, which is licensed to Way Broadcasting Licensee, LLC.
5. Further, in accordance with the Programming Agreement, RM Broadcasting employs, and I personally oversee, a contractor to review the programming aired on WZHF each quarter and prepare a report reflecting programming responsive to issues of interest to the WZHF community. These issues programs reports are then provided to Way Broadcasting for upload to the WZHF online public inspection file.
6. I have reviewed the Opposition to Petition to Deny and Revoke (filed May 4, 2022).
7. The descriptions of WZHF programming included in the Opposition are true and correct to the best of my knowledge and belief.

Dear Congresswoman Eshoo:

Thank you for your letters concerning Federal Communications Commission (FCC) disclosure requirements for broadcast programming. I understand the importance of ensuring that consumers are aware of the sponsor of paid programming, and I am happy to address below the issues you have raised.

You ask that the Commission investigate FCC licensees to determine whether any may have aired broadcast programming by foreign agents—specifically, programming from RT and Sputnik—without proper sponsorship identification disclosure. You are correct that under our rules, broadcast stations must comply with the Commission's sponsorship identification rules. These rules generally require that when money or other consideration for the airing of program material has been received by or promised to a station, its employees, or others, the station must broadcast full disclosure of that fact at the time of the airing of the material, and identify who provided or promised to provide the consideration.

The Commission has not received any evidence that the stations that carry RT or Sputnik programming are in violation of those rules, beyond the references provided in your letters. (To be sure, the Commission has received a small number of complaints from listeners or viewers objecting to the broadcast of RT and Sputnik programming aired on FCC-licensed stations, but as you know, the First Amendment and the Communications Act generally bar the Commission from interfering with a broadcast licensee's choice of programming.)

Based on the information provided in your letters, I have instructed the Enforcement Bureau staff to contact the broadcast licensees that air RT and/or Sputnik programming to obtain additional information regarding any issue that may be within the FCC's jurisdiction. The Bureau will take the appropriate action depending on the facts that emerge during that inquiry. I would note that, without prejudging anything in the instant situation, violations of the sponsorship identification rules typically result in a forfeiture or fine for the licensee, as opposed to license revocation. Also, I should point out that the provisions of the Communications Act and the Commission's rules pertaining to sponsorship identification apply to broadcast station licensees and cable systems, but not to third-party programming providers.

I understand your request that the Commission take steps to monitor the airwaves for compliance with sponsorship identification rules, but I am unable to commit to doing so due to



resource constraints. Given its limited resources, the FCC historically has relied on a complaint-based system, rather than first-party monitoring, to help us detect potential violations. Dedicating a significant portion of enforcement resources solely to this issue would jeopardize our efforts to enforce our rules in several other areas. I can commit to you that we will review, and investigate as necessary, any complaints that are received on this issue.

Further, strong and recent agency action serves to put the entire broadcast industry on notice with respect to our sponsorship identification rules and our determination to enforce them. As you may be aware, we recently proposed a record fine for significant violations of our rules when paid programming lacked the required on-air disclosures. That decision incentivizes broadcast stations to ensure that all paid programming contains the disclosures required under Commission rules.

Incidentally, these same sponsorship identification rules apply to all broadcast licensees regardless of where the station gets its programming and whether or not the entity providing the content is a foreign agent under the Foreign Agents Registration Act (FARA). This sponsorship identification disclosure requirement applies to broadcast licensees and cable systems, and is distinct from FARA, which requires that registered foreign agents provide specific labels on any informational materials distributed by the foreign agent. The U.S. Department of Justice would be better suited to address how, and if, FARA's labeling requirements currently apply to the broadcast programming distributed by RT and Sputnik, as the FCC does not have separate enforcement authority over FARA requirements.


Your letters also raise the issue of whether the Commission's foreign ownership rules need review. Those rules have in fact been reviewed relatively recently; in September 2016, the previous Commission unanimously updated them. Additionally, these rules apply to the ownership and control of broadcast stations, not to the source of programming broadcast by such stations. Thus, it is unclear how such rules would be implicated based on the information currently available.

While the Commission's "secondary market" rules allow certain non-broadcast licensees to lease spectrum to third parties, these rules do not permit broadcast licensees to lease spectrum. In addition, Section 310(d) prohibits the de facto or de jure transfer of control of a broadcast licensee without the Commission's approval. This requires each licensee to retain control over essential station matters, such as personnel, programming, and finances. Although the Commission has authority to forbear from enforcing certain provisions of the Communications Act, this forbearance authority does not extend to broadcast licensees.

Finally, your January 30 letter proposes that the Commission require any foreign agents registered under FARA who seek time on broadcast and cable entities to file publicly with the FCC the same political file information currently required of broadcast and cable entities. However, as with sponsorship identification, the provisions of the Communications Act and the Commission's rules pertaining to political file information apply to broadcast station licensees and cable systems, but not to third-party programming providers.

I hope this has been helpful. Please let me know if I can be of further assistance.

Thank you for your letter regarding the status of the Enforcement Bureau's inquiry regarding the broadcast of RT and/or Sputnik Radio programming by certain licensees. The Enforcement Bureau conducted an extensive inquiry into the matter, including issuing several letters of inquiry to the licensees that broadcasted this programming, and determined that under the Communications Act, the Commission's rules, and judicial precedent, there is no enforcement action that could be taken against the licensees in question. Therefore, I have directed the Media Bureau to explore whether the Commission should start a proceeding to review and modify our current sponsorship ID rules as they apply to programming provided by a foreign entity. I expect to have the Media Bureau's recommendations in the coming months for possible consideration by the full Commission.



Dear Chairman Pallone:

Thank you for your letter regarding a broadcast station's right to air legally protected speech. As you note, I have always stood firmly in the defense of the First Amendment for all Americans. Under the Constitution and the Communications Act, broadcast stations have broad discretion to decide what programming to air on their stations. Absent very narrow circumstances, the government cannot and should not investigate stations or revoke licenses based on programming the station airs.

This has been my long-standing position, and there should be no question as to my commitment to these ideals. In fact, just this week, the Commission's Media Bureau and Office of General Counsel denied an emergency petition filed by "Free Press" demanding that the Commission take action to curtail the freedom of the press and investigate, or at least guide, the editorial judgments of broadcast stations. (I have attached the letter denying Free Press's petition for your review.) Standing up for the constitutional rights of broadcast stations means that we must do so in all instances in which their rights appear threatened. I hope that you agree. Indeed, given your position on this powerful Committee and the unique opportunity you have to send a message in this particular case, I strongly encourage you to speak out publicly in favor of the First Amendment—and thus in opposition to this group's misguided petition.


