CLARIFICATION OF INFORMAL OBJECTION DATED JULY 5, 2022

And

RESPONSE TO INTELLI/INSPIRATION MEDIA REPLY DATED JULY 7, 2022

We, Ken Woods and Cory Harris, residing at 9785 NE Murden Cove Drive, Bainbridge Island, WA 98110 are continuing to experience BLANKETING INTERFERENCE from KKOL when broadcasting at 50kW. Please note our Petition to Deny Intelli LLC's license renewal application submitted on January 3, 2022 plus Supplements and our Informal Objection dated July 5, 2022.

Sonos speakers – One correction and one clarification follow.

Correction: The event took place in the afternoon not at night. It took place during the children's nap time.

Clarification: During nap time soft music was playing on our home stereo system and playing through the Sonos speakers located throughout the house. The volume increased dramatically and without any action by a member of our family. We believe the volume increase was caused by blanketing interference from KKOL. The music originated from our home stereo system not from KKOL or another radio station.

White noise machine

Clarification: The spontaneously increasing and decreasing volume and switching white noise tunes (waterfalls, wind blowing through trees, etc.) was during nap time, which occurs in the afternoon when KKOL is broadcasting at its full 50kW power.

The reference to getting a hotel at night was because the children were scared to stay in our home due to the "ghosts."

Some days during nap time we play music and some days we play the white noise machine. This helps calm the children.

The Reply submitted by Intelli/Inspiration Media misread/misinterpreted our Informal Objection in some instances. We admit to making an error when we suggested nap time occurs at night.

The Reply also describes how the station's engineer solved the problem with our garage door. The attorneys were misinformed. We just purchased new garage doors and the salesperson said that we did not need a new garage door opener as ours was very new and a Cadillac of openers. A few weeks after that, our garage door started to malfunction again and we called Kitsap Garage door to fix the issue. They were not able to fix the issue and we decided to purchase a new garage door opener. It too malfunctioned and the Intelli/Inspiration engineer

Intelli/Inspiration Media has mischaracterized our Objection and their Reply is disrespectful. Broadcasting KKOL at 50kW in our community invades our homes and disturbs our quiet enjoyment. We have a right to expect our government (FCC) to protect us from this assault.


