INTERFERENCE COMPLAINT

Sound Broadcasters, Inc. (“Sound”), licensee of WKTG(FM), Madisonville, KY (FIN: 60877) (the “Station”), pursuant to Sections 74.1203 and 74.1204, hereby submits this complaint regarding objectionable interference to full power FM Station WKTG(FM) caused by FM Translator Station W230DH, Hopkinsville, KY (FIN: 202114). W230DH is licensed to HOP Broadcasting, Inc. (“HOP”) and operating pursuant to Program Test Authority while its above-referenced application for license to cover is pending.<sup>1</sup>

W230DH is causing prohibited interference to a full power station in contravention of the Commission’s Rules and has failed to remedy the interference despite expressly acknowledging its existence within WKTG(FM)’s protected contour. Repeated attempts to seek resolution with

the secondary service's licensee, engineer and counsel have resulted in unacceptable delay, continued interference, and requests for the complaining listener's names and contact information, as well as the contents of this complaint.

The revision to the interference rules in 2019 was designed in part to streamline the interference complaint procedures, protect full power stations, eliminate the need for complaining listeners to be directly involved in the complaint resolution process and stop abuses by the interfering translator, particularly with respect to listener involvement. Nonetheless, HOP's counsel claims that it will... "identify whether interference exists and to resolve listener complaints in a mutually acceptable fashion..."<sup>2</sup> This after HOP's President and engineer both acknowledged the interference and promised to ***promptly change channels***. .

Section 74.1203(a) of the Commission's specifically states ....

"An authorized FM translator or booster station will not be permitted to continue to operate if it causes any actual interference to: .... (3) The direct reception by the public of the off-the-air signals of any full-service station or previously authorized secondary station."

The rule further states that "...

Interference will be considered to occur whenever reception of a regularly used signal is impaired by the signals radiated by the FM translator or booster station, regardless of the channel on which the protected signal is transmitted; except that no listener complaint will be considered actionable if the alleged interference occurs outside the desired station's 45 dBu contour. Interference is demonstrated by:

- (i) The required minimum number of valid listener complaints as determined using Table 1 of this section and defined in § 74.1201(k) of this part;
- (ii) A map plotting the specific location of the alleged interference in relation to the complaining station's 45 dBu contour;

- (iii) A statement that the complaining station is operating within its licensed parameters;
- (iv) A statement that the complaining station licensee has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution; and
- (v) U/D data demonstrating that at each listener location the undesired to desired signal strength exceeds -20 dB for co-channel situations, -6 dB for first-adjacent channel situations or 40 dB for second- or third-adjacent channel situations, calculated using the methodology set out in § 74.1204(b).”

Addressing the rule’s requirements section by section, Sound herein demonstrates without question that W230DH is causing prohibited interference to full power station WTKG(FM). The Commission must order HOP to cease broadcasting on W230DH immediately and dismiss its pending application for license to cover. To wit:

- 1) The protected contour population of WTKG is 372,357 persons. *See Exhibit A* (Engineering Report). Therefore, at least 8 listener complaints complying with the §74.1201(k) requirements must be included. The complaints demonstrating interference from W230DH to WTKG(FM) are attached hereto. *See Exhibit B* (Listener Complaints).
- 2) A map showing the location of the complaints within the WTKG(FM) 45 dBu contour is attached hereto. *See Exhibit A*.
- 3) Sound notified HOP repeatedly regarding the interference to WTKG(FM) and HOP acknowledged that it was aware of the objectionable interference and indicated would promptly change channels. In fact, the owner of Sound, Robert Kelley, contacted the HOP Station Manager, Jeff Sisk, by telephone on June 2, 2022 and was told to contact the licensee’s president and CEO, Mike Tarter. Mr. Kelley then contacted Mr. Tarter on June 3<sup>rd</sup> and 9<sup>th</sup> and was assured they were doing everything they could to move channels quickly.

*See Exhibit C* (Declaration of Robert Kelley). There was also extensive communication between Sound's consulting engineer, George Nicholas, and HOP's engineer, Chuck Anderson, by telephone and additionally by email on June 7, 10 and 21<sup>st</sup>. *See Exhibit D* (Email Correspondence). Finally, the undersigned counsel to Sound reached out via email to HOP's counsel to seek resolution to the interference. Rather than attempt to resolve the matter, HOP's counsel twice demanded the contents of this complaint. *See Exhibit E*.

The admission by HOP's representatives acknowledging awareness of the caused interference (and starkly contrary to their counsel's assertions in their August 5, 2022 letter attached at Exhibit E) and HOP's repeated promises that a change of channel would be forthcoming demonstrate that Sound used commercially reasonable efforts to resolve the interference being caused by W230DH.

In other words, private resolution is at an impasse because, since being informed of the interference HOP has repeatedly stated that it knew W230DH was causing WKTG(FM) interference and that the channel would be changed but, apparently not until the pending interfering license application was granted. This contravenes both the letter and the spirit of the 2019 revisions to the translator interference rule. HOP recognizes the interference and is now waiting to get preferential standing so that it can file a displacement application. HOP made a calculated decision to move in the direction of a co-channel station and improve their facilities; now the predicted interference has manifested itself and the translator must be turned off.

4) WKTG(FM) is operating within its licensed parameters. *See Exhibits A and G*

(Declaration of David Hertel).

5) The U/D data demonstrating that at each listener location the undesired to desired signal strength exceeds -20 dB is attached hereto as **Exhibit A**.

As demonstrated above, Sound has met the Commission's threshold and requests that HOP be directed to cease broadcasting on W230DH immediately and dismiss its pending application for license.

# TRANSLATOR INTERFERENCE ANALYSIS

## WKTG(FM) Ch 230 C2 – Madisonville, KY

This report is a summary analysis of FM signal interference to WKTG (FM) Channel 230 C2, Madisonville, KY. Sound Broadcasters, Inc., licensee of WKTG ("Sound") has retained George Nicholas Communications, LLC., to provide technical consulting regarding destructive interference from co-channel translator W230DH, Hopkinsville, KY., Licensed to HOP Broadcasting, Inc., Hopkinsville, KY.

All of the data herein has been calculated using V-Soft Communication's Probe 5, using the latest FCC and US Census data.

Pursuant to the requirements of 74.1203, we submit the following information:

74.1203 (a)(1) Secondary translator W230DH is causing destructive interference to full-service WKTG 230C2;

74.1203 (a)(3) The maps in this report depict the pertinent 45 dBu contour of WKTG. As shown, all of the noted interference complaints are within the 45 dBu FCC F(50,50) predicted coverage contour. Table 1 of this report includes the names of the complainants, as well as geographic coordinates of the interference site, used in the signal analysis;

74.1203 (a)(3)(i) The required number of complaints is met, and exceeded, based on the population of the WKTG protected contour. The total persons in the WKTG protected contour is 372,357 persons, using the 2022 US Census of Population. This requires WKTG to show a minimum of 8 listener complaints, according to Table 1 of 74.1203 (a)(3);

74.1203 (a)(3)(ii) Map1 and Map2 of this report show the locations of the listener complaints, within the 45 dBu FCC F(50,50) contour;

74.1203 (a)(3)(iii) A Technical Statement from Contract Engineer David Hertel, stating WKTG is operating at licensed output power is also included in this report;

74.1203 (a)(3)(v) Table 1 of this report shows the names and geographic coordinates of the complainants, as well as the predicted (desired) signal of WKTG vs. the (undesired) signal of W230DH. As shown, all of the interfering signals qualify as FCC defined interference, as they are all above the -20 dB minimum required protection for co-channel FM stations (and of course confirmed on the listener's radios). The results of Table 1 were calculated using V-Soft's Probe 5 D/U FCC interference calculations.

I certify this report was made by the undersigned, whose qualifications are a matter of record with the Federal Communications Commission. All of the data is true and correct, to the best of my knowledge and belief.

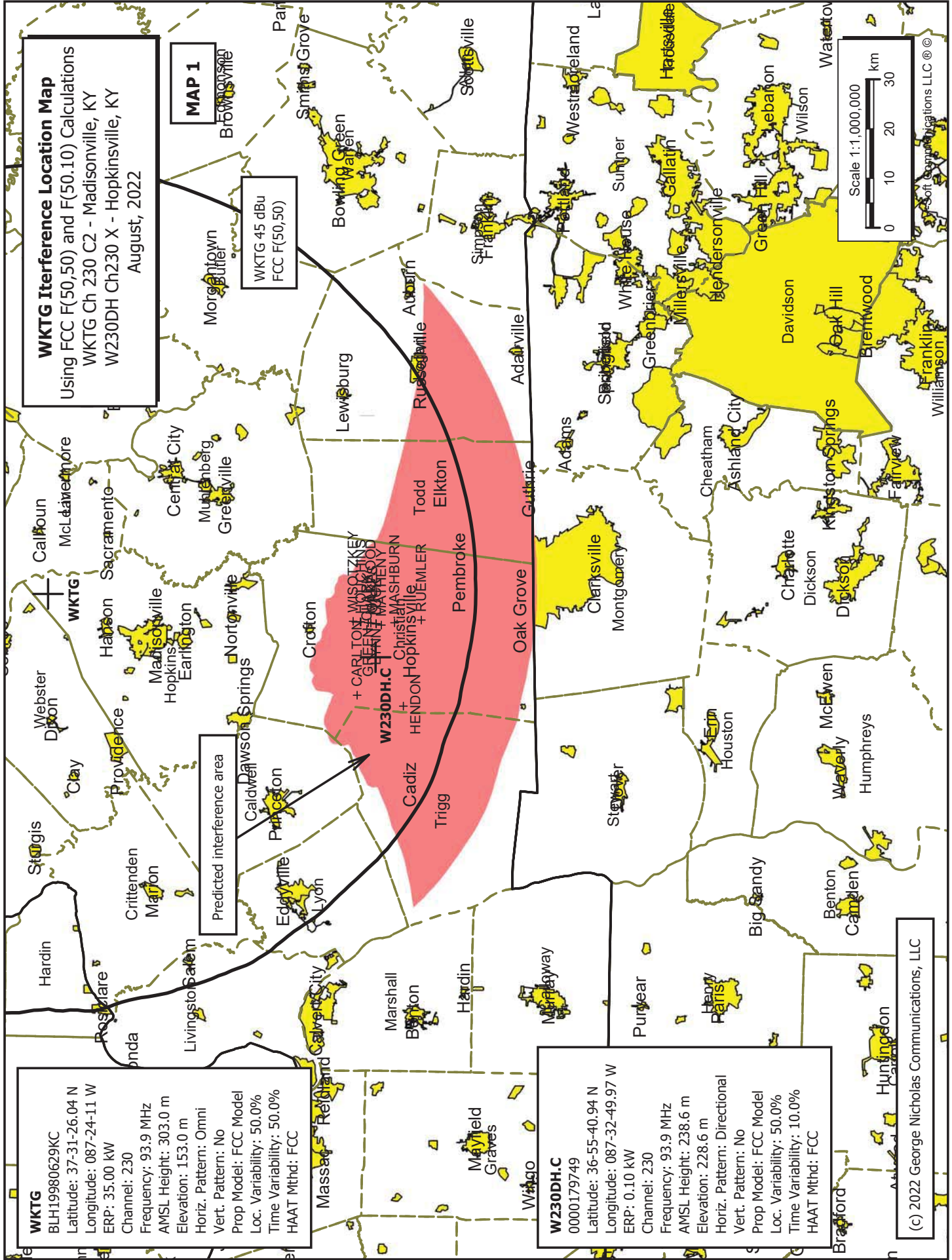

FCC F(50,50)



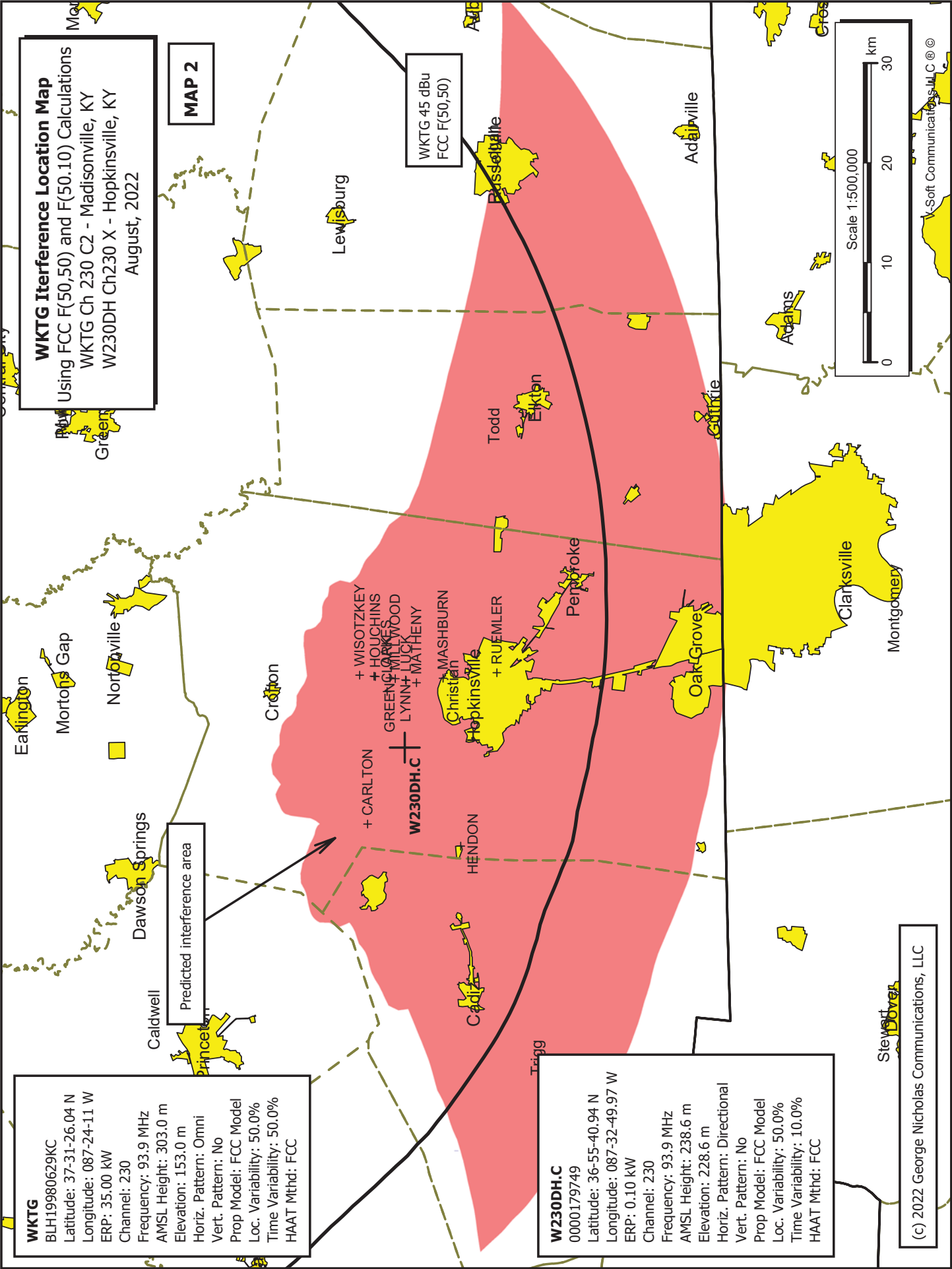



Dear Ms. Sciarrino:

This letter responds to your August 3, 2022 email with the subject of “W30DH (sic) / WKTG Interference”.

This letter constitutes a formal invitation on behalf of HOP Broadcasting, Inc. the Federal Communications Commission licensee of W230DH, Hopkinsville, Kentucky, to provide information on the referenced alleged interference in accord with *Amendment of Part 74 of the Commission’s Rules Regarding FM Translator Interference*, Report and Order, 34 FCC Rcd 3457 (2019) (“*FM Translator Interference Report and Order*”), as affirmed on reconsideration in *Amendment of Part 74 of the Commission’s Rules Regarding FM Translator Interference*, Order on Reconsideration, 35 FCC Rcd 11561 (2020) (“*FM Translator Interference Order on Reconsideration*”). Unfortunately, our previous informal requests for such information have not yet been met with success.

In our previous communications, I requested specific details regarding your client’s allegations that cognizable and actionable interference as recognized by the *FM Translator Interference Report and Order* was indeed occurring to WKTG listeners so that, as contemplated by the *FM Translator Interference Report and Order*, the parties would work together in resolving such claims without the need to burden the Federal Communications Commission. Instead, all we have received from you and your client are unsupported conclusory claims of interference and contour maps which, contrary to one of your statements in your August 3, 2022 email, demonstrate that the subject FM translator was properly granted.

The FCC’s *FM Translator Interference Report and Order*, as upheld by the *FM Translator Interference Order on Reconsideration*, is specific as to what is needed and I direct your attention specifically to paragraphs 11 through 24 in that document, to inform you and your client of such requirements.



HOP Broadcasting, Inc. respectfully requests that it be provided by the WKTG licensee with the following:

- The required minimum number of listener complaints, with each complaint signed and dated by the listener, containing the following information: (1) the complainant's full name, address, and phone number; (2) a clear, concise, and accurate description of the location where the interference is alleged to occur; (3) a statement that the complainant listens to WKTG using an over-the-air signal at least twice a month, to demonstrate the complainant is a regular listener; and (4) a statement that the complainant has no legal, employment, financial, or familial affiliation or relationship with WKTG or anyone associated with it to demonstrate the complainant is disinterested. For the description of the listening locations, please note that the Commission deems appropriate descriptions to include map coordinates, street addresses, street intersections, or other descriptions such as "along Route XX near mile marker XX" or "between Exits 1 and 2 on Route XX" while unacceptable descriptions would include "on my way to work" or "downtown," as they do not inform the complaining station of whether the location is within its 45 dBu contour or provide the translator information with sufficient information to resolve the complaint;
- A map plotting the specific locations of the alleged interference in relation to the 45 dBu contour of WKTG;
- A statement that WKTG is operating within its licensed parameters; and
- U/D data demonstrating that at each listener location the ratio of undesired to desired signal strength exceeds 20 dB calculated using the Commission's standard contour prediction methodology.

You claim in your August 3, 2022 email that you intend on August 5, 2022 to "file a formal complaint with the Commission". I again direct your attention to the FCC's *FM Translator Interference Report and Order* at paragraph 23 which states that a mandatory element of your complaint must include "[a] statement that the [WKTG] licensee has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution (emphasis added)". The WKTG licensee clearly cannot make the statement required by the FCC.

Once we receive the information detailed in the FCC's *FM Translator Interference Report and Order*, we will work together with the WKTG licensee to identify whether interference exists and to resolve listener complaints in a mutually acceptable fashion. We intend to work with willing listeners to resolve reception issues using rule-compliant suitable techniques. We may ask that WKTG engage with us in on-off tests and/or field strength measurements at relevant sites. We may also ask that we together engage a mutually acceptable third-party engineer to observe or carry out testing with shared costs.

As the Commission appropriately notes in *FM Translator Interference Report and Order* at paragraph 24, the parties working together as mandated "will eliminate many interference complaints that may be actually due to weak, distant signals from the desired station or related



issues such as multipath fading, atmospheric ducting, poor reception, or other conditions". Therefore, it is in our mutual interests not to burden the Commission until the parties have had an opportunity to work together with shared information.

Accordingly, we renew our request in this formal letter to work with you and your client to resolve the alleged interference and receive the requested supporting information so that we can review and step towards resolution.
