This letter is being placed on the record to verify applicant Stonewall Alliance of Chico has run local public notice concerning an application for new non-commercial, educational FM station for Willows, California. The public notice occurred late.

FCC has previously ruled that "an applicant's publication of local notice after the 30-day period has elapsed is not a disqualifying defect."<sup>1</sup> The FCC has also consistently allowed "an applicant who has not complied with the rule to publish its local notice late."<sup>2</sup> To that effect, affirmation that public notice is being asserted here to permit the continued processing of the application.
