**INFORMAL OBJECTION**

LKCM RADIO LICENSES, L.P. ("LKCM"), licensee of KTFW-FM, Glen Rose, TX (Facility ID No. 65314), by its undersigned counsel, hereby submits its Informal Objection to the pending application of iHM Licenses, LLC ("iHM") for a License to Cover K221GV, Fort Worth, TX. With respect thereto, the following is stated:

Section 74.1204(f) of the Commission's Rules states, in relevant part:

(f) An application for an FM translator station will not be accepted for filing even though the proposed operation would not involve overlap of field strength contours with any other station, as set forth in paragraph (a) of this section, if grant of the authorization will result in interference to the reception of a regularly used, off-the-air signal of any authorized co-channel, first, second or third adjacent channel broadcast station, including previously authorized secondary service stations within the 45 dBu field strength contour of the desired station. Interference is demonstrated by:

- (1) The required minimum number of valid listener complaints as determined using Table 1 to § 74.1203(a)(3) of this part and defined in § 74.1201(k) of this part;
- (2) A map plotting the specific location of the alleged interference in relation to the complaining station's 45 dBu contour;
- (3) A statement that the complaining station is operating within its licensed parameters;

- (4) A statement that the complaining station licensee has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution; and
- (5) U/D data demonstrating that at each listener location the undesired to desired signal strength exceeds  $-20$  dB for co-channel situations,  $-6$  dB for first-adjacent channel situations or  $40$  dB for second- or third-adjacent channel situations, calculated using the methodology set out in paragraph (b) of this section.

47 C.F.R. § 74.1204(f). Station KTFW-FM operates as a Class C1 FM station on co-channel Channel 221. The K221GV transmitter site is located within the 45 dBu contour of KTFW.<sup>1</sup> Documentation concerning 11 affected listeners are included in Exhibit 1. The evaluation of the listener complaint forms in the Engineering Statement complies with the required showing for a Section 74.1204(f) objection as follows:

- The required minimum number of listener complaints for the population of 405,783 residents within the KTFW-FM 60 dBu contour is a minimum of 9 such listeners as set forth in Amendment of Part 74 of the Commission's Rules Regarding FM Translator Interference, Report and Order, 34 FCC Rcd 3457 (2019) (Report and Order). LKCM has received 11 listener complaints so far. The listener complaint forms are attached.
- A map plotting the specific location of the alleged interference in relation to KTFW-FM's 45 dBu contour is attached in Figure 1 to the Engineering Statement;
- A statement confirming KTFW-FM is operating within its licensed parameters<sup>2</sup>;
- A statement that KTFW-FM has used commercially reasonable efforts to inform iHM of the claimed interference and attempted private resolution.

- U/D data demonstrating that at each listener location the undesired to desired signal strength exceeds -20 dB for co-channel situations, calculated using the methodology set out in paragraph (b) of Section 74.1204. See Table 1 of the Engineering Statement.

In order to avoid the grant of an application that will adversely affect the operations of KTFW-FM and its existing listeners and service, it is requested that the iHM application for a License to Cover the K221GV Construction Permit be dismissed as a violation of Section 74.1204(f) of the Commission's Rules.

This Engineering Statement has been prepared on behalf of LKCM Radio Licenses, L.P., licensee of FM broadcast station KTFW-FM, Ch. 221C1, Glen Rose, Texas (FCC Facility Id 65314). This is in support of an Informal Objection to the pending License to Cover application (FCC File Number 0000214217, Facility Id 202298) for a co-channel FM translator. The underlying Construction Permit is file number 0000213888. Translator K221GV is currently operating pursuant to Automatic Program Test Authority, having completed construction and filed the referenced License to Cover. LKCM Radio Licenses, L.P. has received a number of interference complaints in violation of FCC Rule Section 74.1204(f) from listeners as discussed below.

**Compliance with Section 74.1204(f)**

As shown in the attached **Figure 1**, the co-channel transmitter site is inside the KTFW-FM 45 dB $\mu$  contour, and there is a significant interference area created inside the 45 dB $\mu$  contour of KTFW-FM. The predicted interference area, as indicated by the pink tinted area inside the KTFW-FM 45 dB $\mu$  contour, involves the northern end of Arlington, Texas, which is an area that includes a significant number of KTFW-FM listeners. The area within the KTFW-FM 60 dB $\mu$  F(50,50) contour is home to some 405,783 residents according to 2020 Census data. Per Table 1 in §74.1203(a)(3), KTFW-FM must provide a minimum of 9 listeners within the predicted interference area which listen to KTFW-FM at least twice a month.

Eleven KTFW-FM listeners have submitted declarations stating that they regularly listen to KTFW-FM and live, work, and/or commute in the area of the proposed translator's predicted interference area. All locations were vetted and it was determined by geocoding that these locations were within the proposed translator's interference area. Those 11 locations are listed on the attached **Table I** and have been plotted on the map in **Figure 1**.

Table I also lists the predicted F(50,50) signal from KTFW-FM as well as the predicted F(50,10) interfering signal level of the proposed translator. In order for objectionable interference to occur, the translator signal level must be greater than 20 dB *below* that of the full service FM station. As shown on the table, all points plotted within the coverage map will be well above the level considered interference. In fact, the signals at these points range from 3 dB to 62.4 dB *above* the level at which interference is predicted to occur. Therefore, these 11 regular listeners would receive interference from the proposed co-channel translator as defined in Section 74.1204(f).

**Interference to Other Listeners**

The pink shaded area in Figure 1 shows a portion of the area within the KTFW-FM 45 dB $\mu$  F(50,50) coverage contour that is predicted to receive interference from the proposed translator. All of addresses provided are located in this purple shaded area.

**Certification**





