**STATEMENT FOR THE RECORD--**  
**PLEADING CYCLE SCHEDULE**

Tidewater Communications, LLC (“Tidewater”) hereby respectfully files this Statement for the Record -- Pleading Cycle Schedule (“Statement”) relative to Tidewater’s Consolidated Petition to Deny (“Petition”) the above-captioned applications that Tidewater filed September 3, 2019. In order to avoid confusion as to deadlines relative to the pleading cycle, Tidewater believes it may be conducive to the orderly presentation of pleadings to file this Statement.

On September 27, 2019, counsel for Blue Ridge Free Media filed an Opposition to the Petition. Under Section 73.3584(b) of the Commission’s Rules, Tidewater’s response ordinarily

would be due 20 days after the opposition is due or within 20 days after the opposition is filed, whichever is longer. That would normally make the deadline for Tidewater's response October 23, 2019.


Some of the captioned renewal applicants only recently retained counsel, so Tidewater authorized opposing counsel to state that he would not interpose objections to motions for extensions of time to file oppositions.

On October 11, 2019, a Commission staff member sent an email to all parties (and, where applicable, their counsel), noting that the Commission had received several requests for extension of time and set the deadline for oppositions for all parties at October 25, 2019 (and that the staff would grant no further extensions.) Establishing this date for oppositions would mean November 14, 2019, would be the deadline for Tidewater's Consolidated Reply to the oppositions. By this Statement, Tidewater hereby is confirming its intent to file a Consolidated Reply by that deadline, consistent with the directive issued via email by a member of the Commission's staff.
