JOINT OPPOSITION TO INFORMAL OBJECTION

Comes now, Shanks Broadcasting, LLC (“Shanks”) and Edgewater Broadcasting, Inc., (“Edgewater”), respectfully jointly opposes the Informal Objection (“Objection”) filed by Triangle Access Broadcasting, Inc. (“Triangle”) against the License Renewal Applications listed above.

The basis of Triangle’s Objection is that there is a violation of Section 74.1232 regarding overlap. Shank’s translator W290BD no longer rebroadcasts WBML (AM), rather it rebroadcasts its own station WXKO (AM), Fort Valley, Georgia (Facility ID No. 41988). Attached hereto is a printout of the FCC’s CDBS Database which reflects WXKO as W290BD’s primary station. As W290BD does not rebroadcast WBML, (which is the basis for its objection), Triangle’s objection fails and must be dismissed as **MOOT**.

For the reasons set forth above, the Commission must DISMISS the Informal Objection and APPROVE the Shank's and Edgewater's License Renewal Applications.


