**OPPOSITION TO PETITION TO DENY**

Tri-Cities Broadcasting Foundation (Tri-Cities”), by its attorney, hereby submits its Opposition to the “Petition to Deny” filed by WGHN, Inc. (“WGHN”), with respect to Tri-Cities’ pending application for renewal of license.<sup>1</sup> With respect thereto, the following is stated:

**Background**

Tri-Cities submitted its application for a new low-power FM (“LPFM”) station to serve Grand Haven, Michigan, on November 13, 2013. File No. BNPL-20131113BTL. The Educational Purpose proposed in that application stated as follows:

WE ARE A NON-PROFIT EDUCATION INSTITUTION. OUR MISSION IN PART IS TO PROVIDE EDUCATIONAL DIRECTION IN THE BROADCASTING FIELD TO HELP FOSTER NEW BROADCASTING CAREERS FOR THE RESIDENTS OF WEST MICHIGAN. IN CONJUNCTION THEREWITH, WE WILL PROVIDE 24 HOUR A DAY FREE LOCAL RADIO THAT FOR THE COMMUNITY WE SERVE, BUT ALSO WILL PROVIDE EDUCATIONAL PROGRAMMING WITH RESPECT TO BROADCASTING AS A CAREER. AS A PART THEREOF, WE INTEND TO PROVIDE INDEPENDENT COMMUNITY RADIO TO CITIZENS THROUGH COMMUNITY EDUCATIONAL PROGRAMMING, LOCAL MUSIC ARTISTS NOT CURRENTLY OFFERED BY COMMERCIAL STATIONS, PUBLIC SERVICE ANNOUNCEMENTS, LOCAL NEWS, FEATURE PROGRAMS, INTERVIEWS BY ASPIRING BROADCASTERS, LOCAL SPORTS, WEATHER AND SPIRITUAL PROGRAMMING THAT ARE RESPONSIVE TO THE NEEDS OF THE LOCAL COMMUNITY.

File No. BNPL-20131113BTL, Exhibit 2. No petitions to deny were filed against this application by WGHN or anyone else in any manner claiming that this Education Purpose was inadequate. The application for construction permit was granted on January 11, 2014, and Station WAWL-LP began operation several months later.

The pending application for renewal of license covers Station WAWL-LP's first term of license. Tri-Cities is a non-profit entity under the laws of the State of Michigan. It also is an organization recognized as a Section 501(c)(3) organization as a non-profit educational organization by the Internal Revenue Service. Exhibit 1 (Tax Identification Number redacted). A Certificate of Good Standing issued on September 30, 2020 by the State of Michigan is attached hereto as Exhibit 2.

In the Petition, WGHN claims that Tri-Cities' application for renewal of license must be denied because (i) Tri-Cities is not a qualified nonprofit educational organization under the Commission's Rules as required under Section 73.853(a)(1) of the Commission's Rules (47 C.F.R. § 73.853(a)(1)) (Petition at 1-2); (ii) Station WAWL-LP is not providing non-commercial programming in furtherance of its Educational Purpose (Petition at 5-8); and (iii) WAWL-LP has broadcast commercial advertisements in violation of Section 399b(b)(2) of the Communications Act. 47 C.F.R. § 399b(b)(2) (Petition at 2-5). In support of its Petition, WGHN argues that Tri-Cities' original statement Educational Purpose was deficient and should not have been accepted by the Commission (Petition at 6); that WAWL-LP's programming is not sufficiently "educational" based upon the livestreaming site "Online Radio Box" and WAWL-LP's website (Petition at 6-7 and Exhibit 3); and (iii) attaches transcripts of Internet "livestreams" from "Online Radio Box" to claim that WAWL-FM broadcast over-the-air commercial advertising (Petition at 2-5 and Exhibit 1).

As seen below, Tri-Cities remains fully qualified to be a Commission licensee. Moreover, none of the allegations raised by WGHN raise a *prima facie* case warranting the relief it seeks, namely denial of the pending application of WAWL-LP for renewal of license.

### **Discussion**

Petitions to deny must, pursuant to Section 309(d) of the Act,<sup>2</sup> provide properly supported allegations of fact that, if true, would establish a substantial and material question of fact that grant of the application would be *prima facie* inconsistent with Section 309(k) of the Act,<sup>3</sup> which governs the Commission's evaluation of an application for license renewal. Specifically, Section 309(k)(1) provides that the Commission is to grant a renewal application if, upon consideration of the application and pleadings, it can be found that: (1) the station has served the public interest, convenience, and necessity; (2) there have been no serious violations of the Act or the rules; and (3) there have been no other violations which, taken together, constitute a pattern of abuse." 47 U.S.C. § 309(k)(1). If, however, the licensee fails to meet that standard, the Commission may deny the application - after notice and opportunity for a hearing under Section 309(e) of the Act - or grant the application "on terms and conditions that are appropriate, including a renewal for a term less than the maximum otherwise permitted." 47 U.S.C. § 309(k)(2).

In this case, WGHN provides no basis for even a hypothetical denial of license. As noted above, only three bases are provided in WGHN's Petition for denial of license: (i) alleged lack of qualification under Section 73.853(a)(1) (Petition at 1); (ii) alleged failure to provide proper

programming (Petition at 5-8); and (iii) alleged commercialization by an NCE LPFM station (Petition at 2-5). There is no evidence or else legal precedent to support any of these grounds.

As to the first prong of attack, as noted above, at the time it filed its application, Tri-Cities made a showing, that was accepted by the Commission, that the proposed station will be “used for the advancement of an educational program,” and attached as Exhibit 2 is a Certificate of Good Standing from the State of Michigan establishing that Tri-Cities Broadcasting Foundation remains a non-profit corporation. Tri-Cities therefore remains a qualified non-profit organization as required under Section 73.853(a)(1) of the Commission’s Rules. 47 C.F.R. § 73.853(a)(1). WGHN’s attack on whether WAWL-LP programming as proposed in its 2013 Educational Purpose qualifies it to be a NCE LPLM licensee is grossly untimely. As the record shows, at no time did WGHN ever file an opposition to Tri-Cities’ 2013 application for construction permit, and at no time did the Commission itself ever question the adequacy of the Educational Purpose ultimately approved by the Commission. That approval is now final, and is not subject to question by WGHN at this late date. Therefore, WGHN’s argument in this regard is not an adequate basis for a renewal challenge.

As to the second prong of attack, WGHN’s claims that WAWL-LP’s programming is not adequate to qualify it as a non-commercial educational LPFM station. Petition at 6-7. This also does not even hypothetically qualify as an actionable line of attack. The Communications Act of 1934, as amended, is clear:

Nothing in this Act shall be understood or construed to give the Commission the power of censorship over the radio communications or signals transmitted by any radio station, and no regulation or condition shall be promulgated or fixed by the Commission which shall interfere with the right of free speech by means of radio communication.

47 U.S.C. § 326. As the Commission noted in response to other content-based renewal challenges: "A licensee has broad discretion - based on its right to free speech - to choose, in

good faith, the programming it believes serves the needs and interests of its community of license."<sup>4</sup>: "The Commission will not take adverse action on a license renewal application based upon the subjective determination ... as to what constitutes appropriate programming ."<sup>5</sup> Therefore, WGHN's argument in this regard also is not an adequate basis for a renewal application challenge.

As to the third prong of attack. while WGHN claims that the Commission should deny the WAWL-LP Renewal Application or designate it for hearing for alleged underwriting violations, WGHN does not cite any precedents where such sanctions have ever been imposed for underwriting violations.<sup>14</sup> Indeed, it is settled law, and has long been such, that even hypothetically an underwriting violation is not ever grounds for a proper renewal challenge. *Cesar Chavez Foundation*, 33 FCC Rcd 4338, 4339-40, ¶ 3 (2018) ("we are not aware of...any precedents where [denials of a Renewal Applications] were imposed for underwriting violations"). Therefore, WGHN's third and final argument also is not an adequate basis for a renewal application challenge.

In short, under no reading of Commission precedent can it be found that the WGHN Petition raises matters that even hypothetically constitute a "substantial and material question of fact" that grant of the application would be "*prima facie* inconsistent with Section 309(k) of the Act," which governs the Commission's evaluation of an application for license renewal. 47 U.S.C. § 309(k).

Additionally, facts also not do support its case. Attached hereto as Exhibit 3 is Declaration of Tri-Cities' President, Eric Kaelin, which includes an exhaustive showing demonstrating the meritorious educational and other programming and service to the community performed for WAWL-LP over the last license term. Exhibit 3. Included therein are Issues/Programs lists for the last three years showing the educational and community programming presented on Station WAWL-LP (Attachments 6-8); acknowledgements from various civic and educational organizations thanking the station for its assistance in community endeavors (Attachments 11-23); and letters from educators and political organizations acknowledging the educational programming and services being provided by WAWL-LP. (Exhibit 3, Attachments 2, 3, 9, 10, 11, 12, 24, and 25. These include a Letter from the Associate Director, School of Communications, Grand Valley State University describing WAWL's efforts and supporting the renewal of the WAWL-LP license before the FCC, in which he states:

Please accept this letter as an enthusiastic endorsement of the educational mission of WAWL-LP in Grand Haven, MI, on the occasion of their license renewal filing. I serve as the internship coordinator for the Multimedia Journalism program at Grand Valley State University and have done so for the past five years. I can say without hesitation that the interns we send to work at WAWL come back among the best-prepared young broadcasters in our program. The students are not merely "hanging out" in a radio station, nor are they given menial tasks to perform in exchange for college credit. The students that we send to work at WAWL are trained, critiqued, given a chance to exhibit their talents on air, and come back to our program energized to embark on careers in broadcasting or other communication-related careers.

Speaking as a former broadcaster myself, I know the difficulty in maintaining a quality internship program. I had the task of supervising interns in positions in Chicago, IL; Grand Rapids, MI; Rockford, IL; and Davenport, IA. Interns take no small amount of "care and feeding" to make their experience valuable. Not all broadcasters commit to do this. I note particularly the statement raised in WGHN's objection that asserts that "every radio station with an internship program could be classified as a NCE." That would only be true if every radio station made a true commitment to train and educate the students working for them rather than merely exploiting them as free labor. Given the number of stations just in West Michigan where I no longer recommend that students obtain internships for this very reason, I can aver that no, it is not a common practice for radio stations to provide internships truly worthy of college credit.

Exhibit 3 at Attachment 2. Also attached is a Letter from the Superintendent of Schools, Grand Haven Area Public Schools, which summarizes many of the activities and local area services that have been provided by Station WAWL-LP since its inception, in which he states:

Please accept this letter of support regarding WAWL Community Radio and the important role it plays in the Grand Haven area community

I have worked with and known Mr. Eric Kaelin for the past six (6) years during my tenure as Superintendent of Grand Haven Area Public Schools (GHAPS). During that time, I have found WAWL and Eric to be highly engaged members of the Grand Haven community. WAWL makes it explicitly clear in all interactions that they are servants to our community to share and educate about all that happens across all sectors.

For our public schools, WAWL provides a free weekly spot called the Grand Haven Schools Highlights Show. Each week, the district invites a guest to share and highlight initiatives and programs throughout our schools. This opportunity educates our community on what education looks like today and broadens taxpayers' understanding of how public funds are being leveraged to support student growth and success. Additionally, WAWL actively broadcasts every possible school sporting event and multiple music concerts. This is not limited to high profile sports like football and boys basketball, rather WAWL has provided broadcast of nearly every sport offered by GHAPS. The music concerts that are broadcast have regularly been sold out thus providing access to families and community members that would otherwise not have access.

As a leader, Eric makes it clear that GHAPS has an "open mic" for whenever there is a need to inform and educate the community. Most recently, throughout the pandemic, WAWL broadcast our 2020 Commencement Ceremony. This event was a drive-in event limited to one vehicle per graduate. Knowing that we traditionally have over 3000 guests at our commencement ceremony, WAWL's broadcast (both locally and via the internet) provided access to countless family members and friends right here in Grand Haven and across our country and the world. Similarly, WAWL has interviewed me weekly throughout the pandemic to provide necessary updates to our families and community regarding access to food, changes to learning structures, and future plans. WAWL is the only organization (specifically radio, print media, or electronic media) that has provided this opportunity on such a regular basis. I believe it has been invaluable in keeping our community informed.

Again, WAWL Community Radio has become an essential part of the Grand Haven area community since its inception in 2014. We fully support its continued license with the FCC as a necessary part of keeping our community strong.

Exhibit 3 at Attachment 9. Station WAWL-LP also clearly serves the needs and interests of the community. As Jeff Hawke, Director of Public Safety, City of Grand Haven states in relevant part:

Please accept this letter in full support of our local non-profit community radio station, FM 103.5 in Grand Haven.

Since launching the station, Erik Kaelin has worked tirelessly (sometimes around the clock) to take non-profit educational broadcasting to the next level of excellence. FM 103.5 WAWL has become part of the fabric of our community and I can't imagine not having this important resource in the Tri-cities area.

FM 103.5 WAWL provides the ability for the Grand Haven Department of Public Safety to broadcast real time emergency instructions and information to the entire community, even during times of power outages. This is made possible by a unique partnership between the City of Grand Haven and the radio station. Because of Erik's dedication and dependability, the City of Grand Haven purchased and installed two natural gas generators at WAWL to ensure that the station has power during emergencies. Erik has been instrumental in providing up to date information to the public during several critical incidents...

\* \* \* \*

Educational topics broadcasted include a focus on fire safety, winter weather driving tips, suggestions for parents with assisting teen drivers, home security, emergency medical information including signs of heart attack and stroke, home preparedness for major emergencies (Grand Haven Prepared Initiative), and tips for senior citizens to avoid becoming the victim of scams.

Many members of our community look forward to hearing the annual live and on location broadcast from our department fire prevention open house. Fire safety information is the focus of the broadcast.

WAWL is an important part of our community and provides listeners a personal and unparalleled connection to everything that is Grand Haven.

Exhibit 3 at Attachment 10. Finally, Station WAWL-LP is supported by the State of Michigan Senate.

Attached to the Declaration is a letter from State Senator Roger Victory of the State of Michigan Senate, in which he states:

I write this letter in support of WAWL Community Radio and the educational programming it provides to the Grand Haven, Michigan community.

I began working with Mr. Eric Kaelin at the beginning of the COVID-19 pandemic. He proactively reached out to my office to arrange a weekly on-air talk about current events that are going on in state government. As the State Senator for Ottawa County this was instrumental for ensuring that educational news was being shared with our community.

Over the past 6 months I have been able to easily and consistently update the good people of Grand Haven on the ever-changing landscape that 2020 has brought us, thanks to WAWL Community Radio. To highlight a few of the important topics that we have discussed on-air: Unemployment, Food Supply Chain issues, Agriculture issues, State lawsuits, High Water Erosion, COVID-19 updates, and so much more.



I respectfully request that WAWL Community Radio be granted a renewal of its license with the FCC. WAWL is a part-of the-community and should be allowed-to continue as such. Thank you for your time and consideration in this matter.

In short, even if the Bureau were to engage in a review of programming in a manner not permitted under current law and policy<sup>6</sup>, it can and would be found that WAWL-LP is fully complying with its original Educational Purpose as filed and approved by the Commission and is at the very pinnacle of providing appropriate educational and public interest programming that serves the community.

Finally, WGHN devotes a considerable portion of its Petition claiming that WAWL-LP has engaged in improper commercial advertising upon broadcast station WAWL-LP. Petition at 2-5. However, WGHN provides no transcript of ANY over-the-air announcements that it has heard, and instead states that it has “recorded the livestreams of programming” (Petition, Exhibit 2 (Declaration of Wendy Hart) evidently from “the livestreaming site Online Radio Box” that is relied upon by WGHN for information concerning WAWL-LP. Petition at 7. See also, Petition at 3 (“these spots were recorded by WGHN personnel from the livestreams of broadcasts of WAWL-LP on various days....and were then transcribed”). The FCC, however, does not regulate Internet “streaming” programming or advertising. See, e.g., FCC “The Public and Broadcasting” (August 2019 Edition) at 7 (“we also do not regulation information provided over the Internet...”); FCC Regulatory Free Arena, <https://www.fcc.gov/news-events/blog/2018/06/01/fcc-regulatory-free-arena>. Thus, the transcripts of “livestreaming”

Internet programming provides no basis for FCC action through *i.e.*, denial of a license renewal as requested by WGHN<sup>7</sup>, or even imposition of a forfeiture.

Under Commission precedent, the FCC offers a great deal of latitude in the good faith judgment of broadcasters in ensuring that announcements broadcast by an NCE station are not promotional in nature. *Xavier University*, 5 FCC Rcd 4920, 4921 (1990) (“We recognize that it may be difficult to distinguish at times between announcements that promote and those that identify. We only expect our public broadcast licensees to exercise their reasonable, good faith judgments in this regard”). In this regard, as explained by Eric Kaelin, President of Tri-Cities:

I limit the number of over-the-air underwriting announcements broadcast on WAWL-LP each hour. At our peak we have run four underwriting messages at the top and the bottom of the hour for about 4 minutes per hour during the day between 6:00 am and 12:00 am. At night, between 12:30 am and 5:30 am we run two underwriting messages at both the top and two at bottom of the hour for a total of two minutes per hour at night.

The underwriting announcements are from local businesses, seeking to support their local community station and our programming. I am fully aware of the limitations that must be abided by under restrictions established by the FCC. I don’t usually cold call potential underwriters to this station. Many times, it’s either a discussion that begins at an event we are at or them reaching out to me to see about coming on with us. I always tell the underwriters that if you are going to be a part of this station, it’s because you believe in our mission and not about sales. For underwriting announcements to be broadcast over-the-air, the contract entered into with underwriters specifically states:

Radio Station WAWL is licensed to Grand Haven, MI. and is authorized by the Federal Communication Commission to operate its noncommercial broadcast station on an assigned frequency of 103.5 MHz. The licensee of the Station is the Tri-Cities Broadcasting Foundation Inc. Pursuant to the rules and regulations of the FCC, the parties to this agreement acknowledge that the Station is permitted to broadcast underwriting announcements from for-profit entities, but is not permitted to broadcast commercial advertisements by for-profit entities.

When necessary, it is explained to underwriters that for announcements broadcast over-the-air on Station WAWL-LP, the underwriting announcement may not promote the product, services, or facilities of for-profit entities, and may not contain price information; comparative or qualitative promotional descriptions; or calls to action, but may contain corporate slogans, a brief listing of products and services, value neutral descriptions of a company and its products and services, and telephone and location

information. I limit the number of listings of products or services to that permitted by guidelines indicated by FCC rulings, and to keep underwriting announcements generally short, i.e., no more than 30-40 seconds in length. I write underwriting copy myself, and ask legal counsel to review underwriting spots on a periodic basis. In this way, it is my goal to ensure that underwriting spots broadcast over WAWL-LP meet FCC guidelines.

Exhibit 3 at 6-7. Although WGHN speculates that the announcements broadcast over WAWL-LP itself are excessively promotional (Petition at 4); are “longer than necessary” (Petition at 5); have aired “up to 448 times” (Petition at 5); and accuses WAWL-LP of merely “dress[ing] up the announcements as enhanced underwriting identification” (Petition at 5), the reality of the situation is that all underwriting announcements and policies adopted by Tri-Cities and broadcast by WAWL-LP are well within the limitations imposed upon it by the Commission; underwriting announcements are brief (“30-40 seconds in length”) and infrequent (“[a]t our peak we have run four underwriting messages at the top and the bottom of the hour for about 4 minutes per hour during the day between 6:00 am and 12:00 am. At night, between 12:30 am and 5:30 am we run two underwriting messages at both the top and two at bottom of the hour for a total of two minutes per hour at night.”) and, in light of WGHN’s total failure to provide appropriate evidence to the contrary of its claims, its unsupported allegations and speculations should be rejected.<sup>8</sup>

### **Conclusion**

Following review of WGHN’s presentation, it should be quite clear that WGHN has essentially no clear understanding of the true nature and extent of WAWL-LP’s meritorious programming and its value to the Community of Grand Haven, and has absolutely no first-hand familiarity with the nature of WAWL-LP’s non-commercial programming and underwriting

efforts. Section 309(k)(1) of the Communications Act provides that the Commission is to grant the WAWL-LP renewal application if, upon consideration of the application and pleadings, it can be found that: (1) the station has served the public interest, convenience, and necessity; (2) there have been no serious violations of the Act or the rules; and (3) there have been no other violations which, taken together, constitute a pattern of abuse." 47 U.S.C. § 309(k)(1). Based upon Commission precedent, the totality of the facts presented by Tri-Cities, and the total lack of legal and factual basis for the presentation provided by WGHN, it is clear that WAWL-LP meets all of these requisites, and therefore, the Petition submitted by WGHN, Inc. for denial of the WAWL-LP license must be denied.

**WHEREFORE**, it is respectfully requested that the Petition to Deny filed by WGHN, Inc. be denied.

## **DECLARATION**

I, Eric Kaelin, hereby state as follows:

1. I am President of Tri-Cities Broadcasting Foundation (“Tri-Cities”), licensee of Station WAWL-LP, Grand Haven, MI, Facility No. 196109.

2. Tri-Cities submitted its application for a new low-power FM station on November 13, 2013. The application was granted on January 11, 2014, and began operation several months later. When we started operations with this radio station in July of 2014, we had a dream that we could make a difference in the Grand Haven, Michigan area and help educate, inform, and give those a voice in the Tri-Cities (Grand Haven, Spring Lake and Ferrysburg) area. Also, from the outset, we had a goal of helping young broadcasters hone their skills, not only on the air, but in how a station runs on a daily basis, including the things they don’t teach you in college such as meeting listeners and underwriters and learning how to pull off a successful event such as summer concerts, fundraisers or high school/youth sporting and music events. Most of those things are not taught in college which actually helps them land a job after they graduate. As described in a newspaper story from the Grand Haven Tribune:

WAWL is joining forces with leaders from Grand Haven High School, Muskegon Community College and Grand Valley State University to teach all avenues of such a career path, from marketing and financial aspects to the art of being on the air.

“We’re not in a ratings war — we’re not in competition,” Kaelin said. “We’re going to train new broadcasters and give them a chance to really get on the air. If we can train them properly, they’ll actually be very marketable when they come out.”  
Kaelin said being on the air is just a small portion of a radio career.

“We’re going to teach you how to sell, how to set up a remote, how to put together a promotion, how to deal with people, how to answer the phone,” he said. “There are a lot of basic things that get lost in the cracks when people want to be on the radio.”

3. Station WAWL-LP therefore utilizes interns on a regular basis (except in recent time, due to restriction placed upon us by the University as a result of the COVID-19 pandemic). It is with those goals in mind that I focus so hard on teaching interns those skills, along with allowing the interns to pull a 2-3 hour board shift several times per week while coaching them on-air. Attached is a Letter from the Associate Director, School of Communications, Grand Valley State University describing our efforts and supporting the renewal of our license before the FCC, in which he states:

Please accept this letter as an enthusiastic endorsement of the educational mission of WAWL-LP in Grand Haven, MI, on the occasion of their license renewal filing.

I serve as the internship coordinator for the Multimedia Journalism program at Grand Valley State University and have done so for the past five years. I can say without hesitation that the interns we send to work at WAWL come back among the best-prepared young broadcasters in our program. The students are not merely “hanging out” in a radio station, nor are they given menial tasks to perform in exchange for college credit. The students that we send to work at WAWL are trained, critiqued, given a chance to exhibit their talents on air, and come back to our program energized to embark on careers in broadcasting or other communication-related careers.

Speaking as a former broadcaster myself, I know the difficulty in maintaining a quality internship program. I had the task of supervising interns in positions in Chicago, IL; Grand Rapids, MI; Rockford, IL; and Davenport, IA. Interns take no small amount of “care and feeding” to make their experience valuable. Not all broadcasters commit to do this. I note particularly the statement raised in WGHN’s objection that asserts that “every radio station with an internship program could be classified as a NCE.” That would only be true if every radio station made a true commitment to train and educate the students working for them rather than merely exploiting them as free labor. Given the number of stations just in West Michigan where I no longer recommend that students obtain internships for this very reason, I can aver that no, it is not a common practice for radio stations to provide internships truly worthy of college credit.

4. In addition, Station WAWL-LP provides a high level of service to the local community. Station WAWL-LP broadcasts 17 local newscasts per day, seven days a week; interviews with local leaders nearly every day; coverage of over 100 high school/youth sporting events (pre-COVID-19) a year; local music shows and history shows; and special reports on the latest information available on COVID-19 and how that is affecting our schools and community. Copies of the issues/programs lists I have compiled listing significant community programming that has been broadcast over the past 3 years is attached as Attachments 6-8. I’ve made myself available 24/7 to the Director of Public Safety for any breaking news, severe weather, power outages and traffic updates since we began. There have been several times that I’m at the studio at 2:00 am providing severe weather updates while other stations just run the EAS once and figure that’s good enough. Attached is a Letter from the Superintendent of Schools, Grand Haven Area Public Schools, which summarizes many of the activities and local area services that have been provided by Station WAWL-LP since its inception:

Please accept this letter of support regarding WAWL Community Radio and the important role it plays in the Grand Haven area community

I have worked with and known Mr. Eric Kaelin for the past six (6) years during my tenure as Superintendent of Grand Haven Area Public Schools (GHAPS). During that time, I have found WAWL and Eric to be highly engaged members of the Grand Haven community. WAWL makes it explicitly clear in all interactions that they are servants to our community to share and educate about all that happens across all sectors.

For our public schools, WAWL provides a free weekly spot called the Grand Haven Schools Highlights Show. Each week, the district invites a guest to share and highlight initiatives and programs throughout our schools. This opportunity educates our community on what education looks like today and broadens taxpayers' understanding of how public funds are being leveraged to support student growth and success. Additionally, WAWL actively broadcasts every possible school sporting event and multiple music concerts. This is not limited to high profile sports like football and boys basketball, rather WAWL has provided broadcast of nearly every sport offered by GHAPS. The music concerts that are broadcast have regularly been sold out thus providing access to families and community members that would otherwise not have access.

As a leader, Eric makes it clear that GHAPS has an "open mic" for whenever there is a need to inform and educate the community. Most recently, throughout the pandemic, WAWL broadcast our 2020 Commencement Ceremony. This event was a drive-in event limited to one vehicle per graduate. Knowing that we traditionally have over 3000 guests at our commencement ceremony, WAWL's broadcast (both locally and via the internet) provided access to countless family members and friends right here in Grand Haven and across our country and the world. Similarly, WAWL has interviewed me weekly throughout the pandemic to provide necessary updates to our families and community regarding access to food, changes to learning structures, and future plans. WAWL is the only organization (specifically radio, print media, or electronic media) that has provided this opportunity on such a regular basis. I believe it has been invaluable in keeping our community informed.

Again, WAWL Community Radio has become an essential part of the Grand Haven area community since its inception in 2014. We fully support its continued license with the FCC as a necessary part of keeping our community strong.

Attachment 9. I've worked at bigger full-service stations that can't come close to the attention to community needs that we provide to this community.

5. The reaction we have received from the community in support of our community efforts has been tremendous. The Grand Haven Department of Public Safety recognizes the effort and value of the services provided by Station WAWL-LP, and has offered its support in favor of the renewal of our FCC license, stating:

Please accept this letter in full support of our local non-profit community radio station, FM 103.5 in Grand Haven.

Since launching the station, Erik Kaelin has worked tirelessly (sometimes around the clock) to take non-profit educational broadcasting to the next level of excellence. FM 103.5 WAWL has become part of the fabric of our community and I can't imagine not having this important resource in the Tri-cities area.

FM 103.5 WAWL provides the ability for the Grand Haven Department of Public Safety to broadcast real time emergency instructions and information to the entire community, even during times of power outages. This is made possible by a unique partnership between the City of Grand Haven and the radio station. Because of Erik's dedication and dependability, the City of Grand Haven purchased and installed two natural gas generators at WAWL to ensure that the station has power during emergencies. Erik has been instrumental in providing up to date information to the public during several critical incidents, including:

- Attack on United States Coast Guard Station Grand Haven (At the time, believed to involve explosives)
- Straight line wind storm causing extensive damage, power outages, and a fatality
- Traffic emergencies involving malfunctions with the US-31 Drawbridge at Grand Haven
- Estimated repair times for many power outages
- Road closures due to structure fires, flooding, and other emergencies

In addition to the emergency management component, the Grand Haven Department of Public Safety has partnered with WAWL during the last 6 years to provide a wide variety of educational information and programming.

Educational topics broadcasted include a focus on fire safety, winter weather driving tips, suggestions for parents with assisting teen drivers, home security, emergency medical information including signs of heart attack and stroke, home preparedness for major emergencies (Grand Haven Prepared Initiative), and tips for senior citizens to avoid becoming the victim of scams.

Many members of our community look forward to hearing the annual live and on location broadcast from our department fire prevention open house. Fire safety information is the focus of the broadcast.

WAWL is an important part of our community and provides listeners a personal and unparalleled connection to everything that is Grand Haven.

6. The City of Grand Haven credits WAWL-LP in helping increase local awareness of governmental, school, and civic activities in the Grand haven area through its “broadcast of public meetings, high school sports, club sports, local music scene, detail on emergency weather

conditions and complete news on all local activities” which are broadcast daily on Station WAWL-LP. Attachment 11. Spread the Music Foundation d/b/a Walk the Beat is an organization dedicated to helping children becoming involved with music. Station WAWL-LP has participated in its events. Attachment 12 is a letter from the founder of Spread the Music Foundation acknowledging WAWL-LP’s participation and success with respect to its events. See also Attachments 13 and 14. Thank you cards acknowledging my and WAWL-LP’s activity in the community during WAWL-LP’s first license term have been received from organizations such as Grand Haven Athletics (Attachment 15), Grand Haven Aviation Association (Attachment 16), Grand Haven High School (Attachment 17), Salvation Army (Attachment 18), the United States Coast Guard (Attachment 19), St. Patrick St Anthony Parish (Attachment 20), the Grand Haven Coast Guard Festival (Attachment 21), the Grand Haven Eagles (Attachment 22), and the North Ottawa Community Health System (Attachment 23).

7. The Grand Haven-based North Ottawa Community Health System also supports the renewal of Station WAWL-LP. Jennifer Van Skiver, Chief Communications Officer and Director of External Affairs for North Ottawa Community Health System states:

In my tenure at NOCHS, now more than a decade, I have been privileged to work with a number of organizations that understand the need for and impact of local access to health care. Our partners have found creative ways to leverage their own platform to further our mission. On our behalf, they share our good works, timely information, and educational expertise, lending credibility to our messaging through their endorsement, which increases engagement. They also provide grassroots input that helps us shape and improve our work. Here at NOCHS, we believe this special community culture is a key reason why our community, and the county in which it sits, have been consistently ranked as the healthiest in the State of Michigan.

Clearly, our community has set high expectations for its corporate citizenship. That said, there is a small subset of organizations here that live in even more rarified air. WAWL Radio is among them.

WAWL Radio is a hyper-local informational touchstone for our community. Its owner, Eric Kaelin, operates as a one-man band with enviable energy and passion for his hometown. He has cultivated strong relationships with myriad public services, such as NOCHS, proactively seeking our voices to inform citizens about what's happening here, and to localize national headlines. He manages a number of signature special events that rally the community around important causes and in fellowship. As a non-profit entity, we rely heavily on partners like WAWL to help us permeate the community with information that saves lives. We can think of no greater service than an informed citizenry.

It is our sincere hope that WAWL Radio will be allowed to continue its work of amplifying the education and information we and other public services provide, which is an identifiable part of what makes Grand Haven a safe and welcoming place to visit and call home.

9. In general, Grand Haven is a wonderful community, and community support has been overwhelming. As seen in the attached, the Community of Grand Haven even rallied and pitched in at the Station when I lost my voice for several days late last year. Attachment 26 ("It's humbling and it's flattering," *The Grand Haven Tribune*, December 13, 2019).

10. As is permitted, Station WAWL-LP broadcasts underwriting announcements to finance its operations. Announcements are broadcast over our Internet streaming feed, as well as over the air on WAWL-LP. We also offer advertising availabilities on our Web Site.

11. I limit the number of over-the-air underwriting announcements broadcast on WAWL-LP each hour. At our peak we have run four underwriting messages at the top and the bottom of the hour for about 4 minutes per hour during the day between 6:00 am and 7:00 pm. At night, between 7:00 pm and 5:30 am we run two underwriting messages at both the top and



two at bottom of the hour for a total of two minutes per hour at night. This month we've been running two at the top and two at the bottom of the hour for the most part.

12. The underwriting announcements are predominantly from local businesses, seeking to support their local community station and our programming. I am fully aware of the limitations that must be abided by under restrictions established by the FCC. I don't usually cold call potential underwriters to this station. Many times, it's either a discussion that begins at an event we are at or them reaching out to me to see about coming on with us. I always tell the underwriters that if you are going to be a part of this station, it's because you believe in our mission and not about sales. For underwriting announcements to be broadcast over-the-air, the contract entered into with underwriters specifically states:

Radio Station WAWL is licensed to Grand Haven, MI. and is authorized by the Federal Communication Commission to operate its noncommercial broadcast station on an assigned frequency of 103.5 MHz. The licensee of the Station is the Tri-Cities Broadcasting Foundation Inc. Pursuant to the rules and regulations of the FCC, the parties to this agreement acknowledge that the Station is permitted to broadcast underwriting announcements from for-profit entities, **but is not permitted to broadcast commercial advertisements by for-profit entities.**

When necessary, it is explained to underwriters that for announcements broadcast over-the-air on Station WAWL-LP, the underwriting announcement may not promote the product, services, or facilities of for-profit entities, and may not contain price information; comparative or qualitative promotional descriptions; or calls to action, but may contain corporate slogans, a brief listing of products and services, value neutral descriptions of a company and its products and services, and telephone and location information. I limit the number of listings of products or services to that permitted by guidelines indicated by FCC rulings, and to keep underwriting announcements generally short, *i.e.*, no more than 30-40 seconds in length. I write underwriting copy myself, and ask legal counsel to review underwriting spots on a periodic basis. In this way, it is my goal to ensure that underwriting spots broadcast over WAWL-LP meet FCC guidelines.

13. I am passionate and dedicated to operating an LPFM Station that embodies the FCC's vision for valuable community radio that serves the public.

I declare under penalty of perjury that the forgoing is true and correct.

Eric Kaelin, a former general manager of Grand Haven radio station WOLN, launched WAWL-LP

The call letters represent the names of Kaelin's wife and children. The low-power station broadcasts live community radio from a building immediately east of Rycenga Lumber at 1097 Jackson St.

Kaelin said the new classic rock listening choice is no competition for WGHN because it only has a range of about seven miles and its mission is on an entirely different frequency. He said WAWL is a nonprofit entity, focused on training high school and college students in various aspects of a broadcasting career.

WAWL is joining forces with leaders from Grand Haven High School, Muskegon Community College and Grand Valley State University to teach all avenues of such a career path, from marketing and financial aspects to the art of being on the air.

"We're not in a ratings war — we're not in competition," Kaelin said. "We're going to train new broadcasters and give them a chance to really get on the air. If we can train them properly, they'll actually be very marketable when they come out."

Kaelin said being on the air is just a small portion of a radio career.

"We're going to teach you how to sell, how to set up a remote, how to put together a promotion, how to deal with people, how to answer the phone," he said. "There are a lot of basic things that get lost in the cracks when people want to be on the radio."

Students aren't the only ones who will get exposure through WAWL. Local music enthusiast and Walk the Beat director Dave Palmer is partnering with the station to feature local bands.

"We've been trying to get something like this going for several years," Palmer said. "West Michigan has some renowned musicians who still can't get heard on the radio. We'll do interviews mixed with music. It's a fantastic opportunity."

WAWL also features local news, sports, weather and traffic updates.

Kaelin is the station's general manager and serves as president of the Tri-Cities Broadcasting Foundation, which operates the station. His wife, Amanda, is the foundation's vice president and Floyd Fonte is secretary.

Even though WAWL's output is only 100 watts, the station can be heard around the world through its website, 1035wawl.com.

Please accept this letter in full support of our local non-profit community radio station, FM 103.5 in Grand Haven.

Since launching the station, Erik Kaelin has worked tirelessly (sometimes around the clock) to take non-profit educational broadcasting to the next level of excellence. FM 103.5 WAWL has become part of the fabric of our community and I can't imagine not having this important resource in the Tri-cities area.

FM 103.5 WAWL provides the ability for the Grand Haven Department of Public Safety to broadcast real time emergency instructions and information to the entire community, even during times of power outages. This is made possible by a unique partnership between the City of Grand Haven and the radio station. Because of Erik's dedication and dependability, the City of Grand Haven purchased and installed two natural gas generators at WAWL to ensure that the station has power during emergencies. Erik has been instrumental in providing up to date information to the public during several critical incidents, including:

- Attack on United States Coast Guard Station Grand Haven (At the time, believed to involve explosives)
- Straight line wind storm causing extensive damage, power outages, and a fatality
- Traffic emergencies involving malfunctions with the US-31 Drawbridge at Grand Haven
- Estimated repair times for many power outages
- Road closures due to structure fires, flooding, and other emergencies

In addition to the emergency management component, the Grand Haven Department of Public Safety has partnered with WAWL during the last 6 years to provide a wide variety of educational information and programming.

Educational topics broadcasted include a focus on fire safety, winter weather driving tips, suggestions for parents with assisting teen drivers, home security, emergency medical information including signs of heart attack and stroke, home preparedness for major emergencies (Grand Haven Prepared Initiative), and tips for senior citizens to avoid becoming the victim of scams.

Many members of our community look forward to hearing the annual live and on location broadcast from our department fire prevention open house. Fire safety information is the focus of the broadcast.

WAWL is an important part of our community and provides listeners a personal and unparalleled connection to everything that is Grand Haven.

In the years since WAWL began operating at Jackson Street, we have seen a spike in local awareness of governmental, school and all civic activities in Grand Haven. WAWL produces a deep and compelling volume of local origination programming that is lacking in many Michigan Communities. Public meetings, high school sports, club sports, local music scene, detail on emergency weather conditions and complete news on all local activities are broadcast daily at 103.5.

I've checked with my colleagues across our State. I have found no other local government in Michigan that produces a live radio broadcast of every single City Council meeting. Many Cities, villages and townships broadcast their meetings on paid local cable television, but WAWL smashes economic barriers by providing complete coverage of every word spoken at no charge to the public at 103.5 FM. This is only one example of the dramatic impact this community radio station has had in Grand Haven.

WAWL invested in a generator to broadcast emergency contact during power outages. This seemingly small issue becomes monumental when we have no power and severe weather threatens the safety of our citizens. Without WAWL, instant, local access to critical emergency notifications would disappear.

## Township hears from rental property owners

Grand Haven Township Board members have heard from people in favor and those not in favor of a proposed short-term rental ordinance. On Monday, members of the community came out to share their thoughts on the proposed ordinance during a first reading at the board meeting. The board then tabled the discussion.

Stacey Fedewa, the township's community development director, said the proposed ordinance stems from an increase in complaints about short-term rentals in the area.

"The goal is to preserve the character and integrity of our neighborhoods," she said.

Since the matter was taken up, the board and township staff have heard from residents who would like to see short-term rentals banned completely. At a meeting in mid-August, audience members said rentals have created a stir in some neighborhoods and the sites could undermine the community. Complaints from the August meeting included the noise level from guests renting a house for a weekend. With many seats filled at Monday's meeting, the Township Board heard from a different side of the spectrum: people who own rental properties.

Susan Vanse noted some of the issues the township is noticing, such as noise, are from people who don't care. However, she said most rental owners care quite a bit about who stays in their homes.

"Make us register," said Doug Vanse. "You already know where we are, you have us on the map," indicating a map that shows where short-term rentals could be allowed based on zoning. "Police the ones that have complaints."

Those who spoke noted that, with the American Dunes Golf Club under construction, golfers will come from all around to play the course. With potential restrictions on where a short-term rental can be placed and for how long people could stay, golfers may need to look at lodging out of the area.

Kathy Olds, who said she was speaking for neighbors who could not attend the meeting but own a short-term rental property, said the township could see a drop in tourism dollars if rentals are not allowed.

"I think you're trying to kill tourism," she said. "Grand Haven relies on tourism."

Short-term rental property owners Kevin and Mindi Freng shared their experiences working with the township regarding their house. Mindi said after renting the property years ago, she and her husband purchased the home in 2017 and have continued to use it as a short-term rental. She said her plan is to slowly cut back on the amount of time the home - which has been a rental for more than 15 years - can be rented until she and her family can make it their main residence.

On Monday, Mindi Freng told board members that she had little notice about a complaint, not pertaining to noise or other such complaints about renters, before having to cease operations in July.

"We may need regulations," she said. "But, it feels like one hoop after another and, in the meantime, I can't rent for next season. We have the very real possibility that we might lose our cottage because of this."

## 'It's humbling and it's flattering'

COMMUNITY RALLIES TO HELP WHEN RADIO STATION OWNER LOSES HIS VOICE

If there's one thing a radio host can't afford to lose, it's his or her voice.

But due to a sudden onset of laryngitis, Eric Kaelin - owner, general manager and the only employee at Grand Haven's WAWL (103.5 FM) - found himself without a voice this week.

Perhaps he got a little excited during last Friday's basketball broadcast, or he got a bit too vocal during Saturday's Jingle Bell Parade. Regardless, come Sunday night, Kaelin knew he was in trouble.

"Sunday night, I'll be honest, I was near tears," he said. "I was emotional, because I was like, I don't know what we're going to do. All my interns were graduated. It's just me. I've got nobody. My wife said, 'You always figure it out.'"

When he got into his office early Monday morning, Kaelin still couldn't talk, and his listeners noticed. He received several text messages asking him why he wasn't live on the air.

"I put a thing on Facebook. I've got laryngitis. I can't talk - and just putting it out there, does anyone want to come down and read a weather forecast?" he said.

It was more of a joke than a plea of desperation. Regardless, Kaelin's listeners - many of them friends, but many others whom he had never met - came to the rescue.

"I was figuring, nobody's going to respond," he said. "The next

thing you know, everyone's responding."

Over the course of the next three days, dozens of people visited WAWL's studio on Jackson Street next door to Iyenga Lumber. Less than 12 hours after his Lakers won their season-opener, Spring Lake boys basketball coach Bill Core was in the studio to read the previous night's sports scores.

Grand Haven City Manager Pat McGinnis visited to read the weather, and couldn't resist his chance to take a shot at Kaelin. "Good morning, Tri-Cities, it's a Christmas miracle," McGinnis said. "God finally gave Eric laryngitis so we don't have to listen to him this holiday season - a little break for you and me."

That started a trend that others followed. Dave Palmer, who for years headed up Walk the Beat, also jumped at the opportunity

to have some fun at Kaelin's expense.

"Hey, everybody, it's Dave Palmer here at 103.5 WAWL, filling in for Eric Kaelin, who is down in the dumps," Palmer said. "He doesn't sound good and he doesn't look any better."

Even Kaelin's doctor got into the act. "It's Matt Check (and) I'm a doctor at Mercy Health Physician Partners and I take care of Eric," he said. "And much to all of your disappointment, I'm trying to get that voice back for him."

Kaelin said a lesson he learned early in his radio days is that the best way to run a great station is to include the people in the community - "radio for the people, by the people," he said. This week's experience reinforced that.

"It's very humbling, to be honest with you, that people think

enough of this station and feel sorry enough for me to want to come down here and help," Kaelin said. "And they're not radio people. It's hard, people are scared. They're not used to it and they don't want to mess up. I get that. I don't want them to feel bad or embarrassed, so we edit out their mistakes, we do it again. We go back and listen, make sure they sound right, because they're going to tell all their friends about it."

Kaelin's friend, Kenny Baumgardner, texted at one point and said he was having a blast listening to hear who would be the next person on the air.

"It's humbling and it's flattering," Kaelin said. "I think it's really cool that people took five minutes of their day to come down here and do a weather forecast, do the sports scores. It's been fun."
