INFORMAL OBJECTION

Triangle Access Broadcasting, Inc. (“Triangle”), pursuant to 47 C.F.R. §73.3587, objects to the grant of the above-referenced application (the “Application”). On January 11, 2021, the Bureau accepted for filing Community Broadcasting, Inc.’s (“Community”) Application to license K241CZ. Triangle objects on the grounds that its grant makes K292FO (facility ID 138457, Rolla, MO) an unnecessary translator that would be overlapped more than 85% by the commonly owned combination of KFCV (facility ID 173766, Dixon, MO) and the subject K241CZ. The three stations— as well as the primary station, KMOZ(AM) (facility ID 53651, Rolla MO), for the two translators— all retransmit the same programming. As such, Triangle hereby makes a *prima facie* showing that K292FO would become unnecessary with the licensing of K241CZ.¹ Community should be required to submit a

technical need demonstration before the additional translator can be licensed.² Alternatively, the Bureau should require that K292FO's primary station be changed to avoid a substantially redundant service that does not serve the public interest, convenience and necessity.

Exhibit A shows the F(50,50) contours of the translators and FM station KFCV, all retransmitting the same programming. K292FO would be a same-area translator with no obvious technical need because over 85% of its area would be overlapped by other sources of identical programming in the FM band.³ Of course, K292FO is a cross-service translator for KMOZ with a service contour that lies wholly within the KMOZ 2 mV/m daytime service contour, yet an additional signal serving that area.⁴

Exhibit B shows a "Bott Radio Network" station list that includes 90.5 FM in Dixon, MO, (KFCV) and 1590 AM / 106.3 FM in Rolla, MO (KMOZ and K292FO). Because W241CZ shares the KMOZ primary with K292FO, it must also carry the same programming.

In order for Community to be licensed as the public fiduciary of this additional spectrum, the Bureau should ensure that the population in the area of K292FO is better served. The Bureau should dismiss the Application unless the K292FO spectrum is returned or a diversity of programming is offered.


