AMENDMENT TO INFORMAL OBJECTION

Press Communications, LLC (“Press”) hereby amends its May 4, 2022 Informal Objection to reference Section 74.1263 of the rules of the Federal Communications Commission (“Commission”) pertaining to time of operation of FM translator or booster stations.¹

Based on the facts set forth in the Informal Objection, the lack of notification to the Commission of Best Media, Inc.’s intent to either discontinue operations for 30 or more consecutive days or permanently discontinue operations violates Sections 74.1263 of the Commission’s rules.² Moreover, failure to operate for 30 or more consecutive days is deemed evidence of discontinuation of operation and the station license of the station may be cancelled at the discretion of the Commission pursuant to Section 74.1263(e) of the Commission’s rules.³

Though there is sufficient evidence that FM Translator station W264CW has expired as a matter of law for failing to transmit broadcast signals for a 12-month period, the Commission should nevertheless exercise its discretion to cancel the station license.


