Gallup Public Radio is incorporated in the state of New Mexico as a domestic non-profit corporation. 47 CFR § 73.3513 (a) (3) states that applications made by such an entity must be signed by an officer. The signer of these applications, Rachel J. Kaub, is not listed as an officer


or director of Gallup Public Radio where the parties to the application are listed on the application in question, nor are they listed as an officer or director in Gallup Public Radio's listing on the New Mexico Secretary of State's website. As such, the aforementioned applications should be dismissed.
