EXHIBIT TO INFORMAL OBJECTION TO RENEWAL OF KSKQ-FM LICENSE

In the content of this letter, is an 'Exhibit' of an email sent to me by one of the recipients, Sallie Mix who was cc'd during an attempt to contact then Program Director, Jeff Westergaard of KSKQ-FM regarding a 'Call To Action' during a late night radio program on KSKQ-FM.

The email states that the recipient, Rob Engorn, had been terminated from his radio show and his participation at that 'Community Radio Station' for alerting the management of a 'Call to Action' by a programmer named Ray Hessel, aka 'DJ BALE DEL NORTE' who is a current programmer at KSKQ-FM featuring a show named 'REALM OF BASS'. The email demonstrates the writers termination over his objection to the unauthorized broadcasting of the notorious Alex Jones 'InfoWars' podcast on KSKQ, calling for an insurrection prior to the January 6th attempt to overthrow the United States government.

I urge you to pay particular attention to the sentence that pertains to Mr. Engorn's removal for objecting to Mr Hessel's unauthorized and apparent 'Call To Action' to participate in an insurrection and threat to disrupt the constitutional count of electoral votes.

One can only conjecture that perhaps Mr. Hessel is an operative of Mr. Jones and might have been compensated for having access to community airwaves and using those airwaves to perpetrate the narrative and 'Call to Action' by Mr. Jones and the 'InfoWars' podcast.

Never the less, Mr. Engorn and Ms. Mix where both terminated with extreme prejudice for objecting to the actions of Mr. Hessel and the unauthorized use of 'Community Radio' as a springboard to a 'Call to Action' to foment an insurrection.

I would contend that the email provided below is only one form of *prima facie* evidence that the renewal of the broadcast license for KSKQ-FM should be investigated and determined if the license would be better transferred to a more responsible and competent license holder.

Hi Sallie, Hi Jeff,

Thank you for your recent email.

I'm on the road, returning from a family reunion in the mid-west. I'm passing through Shoshone territory, in the area known as Nevada.

Have you had a chance to watch the January 6th Hearings? According to evidence presented there, Trump and his associates in the Proud Boys militia led an insurrection by an armed militia to disrupt the counting of the electoral votes (including your vote), with the intention to assassinate the Vice President. As you may recall, my complaint about DJ Bale broadcasting the Alex Jones "Info-Wars" program that included an illegal call to action, and call to insurrection, resulted in my termination from KSKQ for complaining, and the continuation of DJ Bales programming. Now that new information has been revealed by the January 6th Committee, and now that Alex Jones has been indicted, I think it is time to review and reverse your decision. I'm due an apology. My show title should be removed from the KSKQ Schedule, and DJ Bale should be retired.
