WITHDRAWAL OF INFORMAL
OBJECTION

Magnum Communications, Inc., licensee of WMBZ (FM), West Bend, WI (“MCI”), by its undersigned counsel, hereby withdraws its Informal Objection (as supplemented, the “Objection”) relating to the pending application (“Application”) of Polnet Communications, Ltd. (“Polnet”) for a construction permit for modification of license of W223CN, Zion, IL, the Objection having been filed on February 17, 2023 as LMS Pleading No: 0000210971, as initially supplemented on March 3, 2023 by LMS Pleading No: 0000211803 (the “Initial Supplement”) and second supplement filed March 17, 2023 by LMS Pleading No: 0000212684 (the “Second Supplement”) and Third Supplement filed April 3, 2023 by LMS Pleading No: 000021394 (the “Third Supplement”).

Polnet has further amended its Application and filed a Response to the Third Supplement of MCI (LMS Pleading No: 0000213902) and in connection therewith has satisfied MCI’s interference concerns regarding the proposed facility. Accordingly, MCI withdraws its Informal Objection to the Application. MCI fully intends to visit and document any final W223CN construction to assure WMBZ(FM) is afforded full protection as outlined under 47 C.F.R. §74.1204; and that regarding use of the previously specified IRTE Model P3AC-1R directional antenna (as certified in LMS application#0000208896), MCI will further pursue any action as necessary to assure compliance with 47 C.F.R. §74.1251.

WHEREFORE, it is requested that the Informal Objection, as supplemented be dismissed and the Application processed by the Audio Division.
