**SUPPLEMENT TO PETITION FOR RECONSIDERATION**

**Vida Ministry, Inc. failed to disclose its attributable interest in KHGF-LP.**

Vida Ministry, Inc. (“Vida”), tentative selectee of FCC MX Group 200, did not disclose that its 75% voting interest director “Zulma Nava Sanchez” has an attributable interest in station KHGF-LP Houston, Texas (Facility 195789). “Zulma Nava Sanchez” is shown having 51% voting interest in KHGF-LP in the organizational chart in LMS File Number 0000135258 and is shown to have the title of President in the certification of the currently active KHGF-LP license. The phone number (832) 233-8128 that appears in the Vida application is the same number listed in the current KHGF-LP LMS facility record. The same “Zulma Nava Sanchez”, the phone number (832) 233-8128, and e-mail “zulmanavasanchez@gmail.com” that are listed in the Vida application File No. 167104 appear throughout numerous application filings for KHGF-LP:

Therefore, Vida’s “No” certification to the questions “Does the applicant **or any party** to the application have an attributable interest in any other broadcast station(s)” was FALSE and misleading because a party to the application has a majority interest in KHGF-LP. Furthermore, Vida did not pledge to divest KHGF-LP should it be awarded a construction permit in any of its 10 applications filed during the 2021 NCE-FM window. The fact that Vida has undisclosed

interests in a least one other broadcast station is material to the outcome of MX Group 200 because Vida claims two points for diversity of ownership which does not consider KHGF-LP and the Commission accepted Vida's false certification that "it has no attributable interests in any radio authorization" when in fact the majority party to the Vida application has a majority interest in KHGF-LP Houston, Texas. The points awarded on these two false claims were dispositive in the Commission's determination of Vida as the tentative selectee.

**Vida Ministry, Inc. will not advance its own Educational Objective.**

Vida was required to "provide an exhibit showing that it has an educational objective and that the station will be used for the advancement of an educational program that will further that objective...." Vida provided an "Educational Statement" listing the objectives of a completely different organization "**Centro Cristiano de Vida Eterna San Antonio Texas**" which also filed multiple applications during the 2021 NCE-FM window under FRN 0031606387.<sup>1</sup> The "Educational Statement" in all five of the FRN 0031606387 "Vida Eterna" applications are identical to the statements in the ten Vida Ministry, Inc. (FRN 0031609308) applications. The combined fifteen applications filed during the NCE window provided the exact same Educational Statement naming "**Centro Cristiano de Vida Eterna San Antonio Texas**", and no applications stated the educational objectives of Vida Ministry, Inc.<sup>2</sup> Therefore, Vida Ministry, Inc., tentative selectee of MX Group 200 has not established its basic qualifications to become the license of the ten non-commercial educational stations that it proposes.


