**SUPPLEMENT TO  
CONSOLIDATED PETITION TO DENY PENDING LICENSE  
APPLICATION & REQUEST FOR IMMEDIATE REVOCATION OF  
OPERATING AUTHORITY**

Delmar Communications, Inc. ("Delmar"), Licensee of Radio Station WVXG-FM (74300) at Mount Gilead, Ohio, by counsel, hereby submits this Supplement to its original Consolidated Petition seeking the denial of pending license application BLFT-20170608AAP for Channel 236 (95.1 MHz) operations for FM Translator Station W236CZ at Columbus, Ohio, as well as the revocation of that FM translator station's operating authority.

Delmar's original Consolidated Petition referenced seven interference complaints from regular and loyal listeners of WVXG-FM. Delmar has received three additional listener complaints and they are attached to this Supplement as Attachment No. 1.<sup>1</sup> These three listeners reside over a wide area stretching from Marion, Ohio to Ostrander, Ohio to




