**REQUEST FOR EXTENSION OF TIME**

Sewanee Phoenix License, LLC (“Sewanee Phoenix”) and Gabrielle Broadcasting Licensee Ordinal I, LLC (“Gabrielle”), by its attorneys, hereby requests an extension of time until April 14, 2017 to file its response to the pleadings Barna Broadcasting, LLC (“Barna”) filed against the above referenced license and permit application.<sup>1</sup> Sewanee Phoenix is the present licensee and Gabrielle the proposed assignee of K241CS.<sup>2</sup> Barna is the licensee of KSWG(FM), Wickenburg, Arizona and alleges that K241CS is causing actual interference to the over the air reception of KSWG. Barna submitted interference complaints from listeners of KSWG in support of the Informal Objection and Complaint.

Good cause exists for granting the extension request. Sewanee Phoenix is in the process of selling FM translator station K241CS (along with the companion AM station KXEG) to Gabrielle. The parties intend to close on this transaction and a related transaction for the sale of


KQFN(AM), Tempe, Arizona the first full week of April.<sup>3</sup> Currently the parties to these transactions are in the midst of constructing and collocating new facilities for KQFN upon the KXEG tower site, a condition precedent for the two closings. Representatives of Sewanee and Gabrielle have been in contact with representatives of Barna prior to their filing the subject pleadings in an effort to address Barna's concerns. Upon consummation of the sale of K241CS and KXEG, Gabrielle will be able to fully address the matters raised in the Informal Objection and Complaint.

Wherefore, for the foregoing reasons, Sewanee Phoenix, LLC, and Gabrielle Broadcasting Licensee Ordinal I, LLC respectfully request a brief extension of time until April 14, 2017 to file their response.


