CONSENT MOTION FOR EXTENSION OF TIME

Entercom License, LLC (“Entercom”), licensee of FM translator station K277AE, Seattle Washington (FCC Facility ID No. 18522), by its attorneys, hereby requests a two-week extension of time to oppose the Petition for Reconsideration (the “Petition”) of the grant of the above-captioned license application filed on November 3, 2017 by Everett-Snohomish Broadcasting (“Everett-Snohomish”).

Under Sections 1.4 and 1.106(g) of the Commission’s Rules, Entercom’s opposition would normally be due on November 16, 2017. Entercom previously notified the Commission that it will be conducting joint tests with Everett-Snohomish the week of November 13.¹ Testing is currently scheduled to conclude on November 16, the date on which the opposition would be due. An extension is warranted so that Entercom has adequate time to review the results of the joint tests prior to filing its opposition.

Because Thanksgiving is one week after the opposition is currently due, Entercom is requesting a two-week extension, through and including November 30, 2017, to file its opposition. Counsel for Everett-Snohomish has graciously consented to the extension.
