SUPPLEMENT TO PETITION TO DENY

Tidewater Communications, LLC (“Tidewater”), by its counsel and pursuant to the request of the Commission staff¹ and Sections 73.5006 and 74.1204(f) of the Commission’s Rules, hereby respectfully files this Supplement to its Petition to Deny filed May 22, 2018 against the captioned application (“Application”) filed by Winchester Radio Broadcasters, LLC (“WRB”) for a construction permit for a new FM translator on Channel 221 at Front Royal, Virginia. Tidewater is licensee of co-channel W221CF, Harrisonburg, Virginia. As Tidewater has previously requested, the Application must be dismissed. In support whereof, the following is shown.

As indicated in Footnote 1, this supplement submits information in compliance with the new rules adopted in the *Translator Interference Order*. The Audio Division’s letter requires Tidewater to submit:

1. Detailed information on the protected contour of W221CF and the population located

therein;

2. The minimum number of listener complaints as determined by the population located within the W221CF protected contour. In this case, because there are 89,584 persons² within the protected contour, a minimum of six complaints are required. Submitted with the Technical Report, attached hereto and made a part hereof, are copies of 18 complaints, a number far in excess of the number mandated by the Translator Interference Order;
3. A clear, concise, and accurate description of the location where interference is occurring;
4. A statement from each listener that he or she listens over-the-air to W221CF at least twice a month;
5. A statement from each listener that he or she had no financial, employment, or familial affiliation or relationship with W221CF or Tidewater;
6. A map plotting the specific locations of the interference in relation to the 45 dBμ contour of W221CF;
7. A statement that W221CF is operating within its licensed parameters;
8. A statement that Tidewater has used commercially reasonable efforts to inform WRB and attempted resolution; and
9. Undesired/Desired data demonstrating that at each listener location the ratio of undesired to desired signal strength exceeds -20 dB for co-channel situations (as this is) calculated using the Commission's standard contour prediction methodology.

The Technical Report furnishes the information requested by the Audio Division.

Item 8 above requires Tidewater to use commercially reasonable efforts to inform WRB and attempt a resolution of the matter. Attachment 2 is a copy of an email exchange between Tidewater's local General Manager, Kim Mitchell, and Edward A. (Ted) Schober, who is Chief Executive Officer of WRB. On September 24, 2019, Ms. Mitchell emailed Mr. Schober and asked WRB to vacate Channel 221 "due to anticipated co-channel interference with Tidewater's W221CF." Ms. Mitchell encouraged WRB to pursue a channel change "in an attempt to privately resolve this issue."

On September 26, 2019, Mr. Schober emailed Ms. Mitchell and noted that a prior construction permit (BPFT-20150710ACY) had expired³ and that an August 2019 amendment WRB made to its application showed that all listeners claimed in Tidewater's Petition fall outside the licensed W221CF F(50,50) 45 dB μ contour.

Mr. Schober added that "absent a showing of predicted interference to listeners of the licensed W221CF in accordance with the present rules, we are disinclined to modify our proposal to another channel without a clear showing that there actually are listeners to W221CF meeting the requirements of Section 74.1204(f) likely to be likely [sic] receive interference from our proposal."

Mr. Schober also indicated, *inter alia*, that WRB was planning to amend its application to specify a simpler antenna "which will produce reduced radiation toward W221CF." However, WRB did not provide any evidence in support. Thus, neither Tidewater nor the Commission can confirm whether such statement is correct.

Consistent with Section 74.1204(f) of the Commission's rules, Tidewater has made a reasonable effort to inform WRB of the potential interference and has asked WRB to change the

channel associated with its new FM translator. WRB has refused. Tidewater also has complied with the Audio Division's request for additional information. Accordingly, the only solution to resolve the interference complaint is for the Commission to DISMISS the Application.

EXPLANATION OF STATEMENT: This Technical Statement has been prepared to support a 47 C.F.R. Section 74.1204(f) based Petition to Deny as submitted by Tidewater Communications, LLC ("Tidewater"), licensee of Translator W221CF.L - Harrisonburg, VA. This Petition to Deny is being filed against FM Translator Application BNPFT-20180501ABU for CH221D.A - Front Royal, VA (Facility ID No. 202519). This Application is held by Winchester Radio Broadcasters, LLC ("Winchester"). The Application in question proposes operation on CH221D (92.1 MHz) with 0.250 kW ERP at 666 meters AMSL. Tidewater Translator W221CF.L - Harrisonburg, VA (Facility ID No. 151081), operates under License BMLFT-20180124AAO with 0.250 kW ERP at 572 meters AMSL on CH221D (92.1 MHz). Therefore W221CF.L operates co-channel to the CH221D.A Translator Application.

Support: In accordance with 47 C.F.R. Section 74.1204(f), an application for an FM Translator station will not be accepted for filing even though the proposed operation would not involve overlap of field strength contours with any other station, as set forth in paragraph (a) of this section, if a grant of the authorization will result in interference to the reception of a regularly used, off-the-air signal of any authorized broadcast station within the 45 dBu field strength contour of the desired station. In implementing 47 C.F.R. Section 74.1204(f), the Commission has established five (5) criteria necessary to demonstrate a grant of an FM Translator Construction Permit Application "will result in interference to the reception" of an existing station. As noted herein, these five (5) criteria have been documented. Therefore, the Translator Proposal in question is no longer acceptable for filing and thus subject to immediate dismissal. The necessary criteria, as previously established by the Commission, have been addressed below.

Criteria 1 - The required minimum number of valid listener complaints as determined using Table 1 of §74.1203(a)(3) and as defined in §74.1201(k). Affected existing Translator W221CF serves a population of 89,597 within its Class D, 60 dBμ F(50:50) Service Contour. Table 1 of §74.1203(a)(3) mandates a minimum of six (6) listener complaints for populations ranging from 1-199,999. There are eighteen (18) total listeners participating in this 47 C.F.R. Section 74.1204(f) based Petition to Deny. Information concerning the affected station's service contours has been included in the **Exhibit 1.1** map showing. Each location has also been noted on the **Exhibit 1.1** map showing. The name and contact information of each listener also appears in the Listener Complaints as found in **Exhibit(s) 2.1 to 2.18**. A summary of each location has been provided below.

Within the *Exhibit 1.1* Listener Map, these eighteen (18) listener declarations have been plotted. Listener areas include stationary home or other addresses and sections of roads or highways. The home and other stationary locations have been identified by the physical mailing address as well as latitude and longitude coordinates expressed as Degree-Minutes-Seconds. The segments of road-based listenership have been highlighted on the map as well. *Based on the beginning and ending landmarks as noted from each complaint (and the proliferation of road mapping software available on the internet), the locations of each of these road-based segments is considered a matter of record before the Commission. Therefore, no further documentation is believed required. However additional coordinate or other identifying documentation of these road-based segments will be supplied upon request.*

Pursuant to current Commission Policy regarding listener documentation¹, each listener statement includes (1) the complainant's full name, address, and phone number or email address; (2) a clear, concise, and accurate description of the location where the interference is alleged to occur; (3) a statement that the complainant listens to the desired station using an over-the-air signal at least twice a month, to demonstrate the complainant is a regular listener; and (4) a statement that the complainant has no legal, employment, financial, or familial affiliation or relationship with the desired station, to demonstrate the complainant is disinterested.

Criteria 2 - A map plotting the specific location of the alleged interference in relation to the complaining station's 45 dBu contour. A map plotting the specific location of each interference complaint location in relation to the affected station's 45 dBu F(50:50) service contour has been included in *Exhibit 1.1*. In this case, more than the minimum number of six (6) individual complaint locations within the 45 dBμ contour have been shown.

Criteria 3 - A statement that the complaining station is operating within its licensed parameters. A declaration that the affected station is operating within its licensed parameters has been included in *Exhibit 3.1*.

Criteria 4 - A statement that the complaining station licensee has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution. A declaration that the affected station has used commercially reasonable efforts to inform the Translator licensee of the claimed interference and attempted private resolution has been included in *Exhibit 4.1*.

Criteria 5 - U/D data demonstrating that at each listener location the undesired to desired signal strength exceeds -20 dB for co-channel situations, -6 dB for first-adjacent channel situations or 40 dB for second- or third-adjacent channel situations, calculated using the Commission's standard contour prediction methodology set out in 47 C.F.R. Section 73.313. The plotted "U to D", Undesired to Desired, contour relationship between the affected station and the offending Translator has been outlined on the attached **Exhibit 1.1** map showing. In all cases, W221CF reception throughout the proposed Translator's U to D calculated interference contour(s) remains subject to co-channel interference greater than 20 dB as outlined in 47 C.F.R. Section 74.1204(a).

SUMMARY OF STATEMENT. As a result of the documentation submitted herein, specifically the existence of eighteen (18) valid W221CF listeners representing a substantial number of distinct locations of observed interference, the Commission is encouraged to immediately enforce the provisions of 47 C.F.R. Section 74.1204(f) whereby Winchester's FM Translator Application BNPFT-20180501ABU for CH221D.A - Front Royal, VA (Facility ID No. 202519) may no longer be deemed acceptable and is therefore subject to immediate dismissal pursuant to 47 C.F.R. Section 74.1204(f).



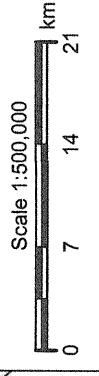

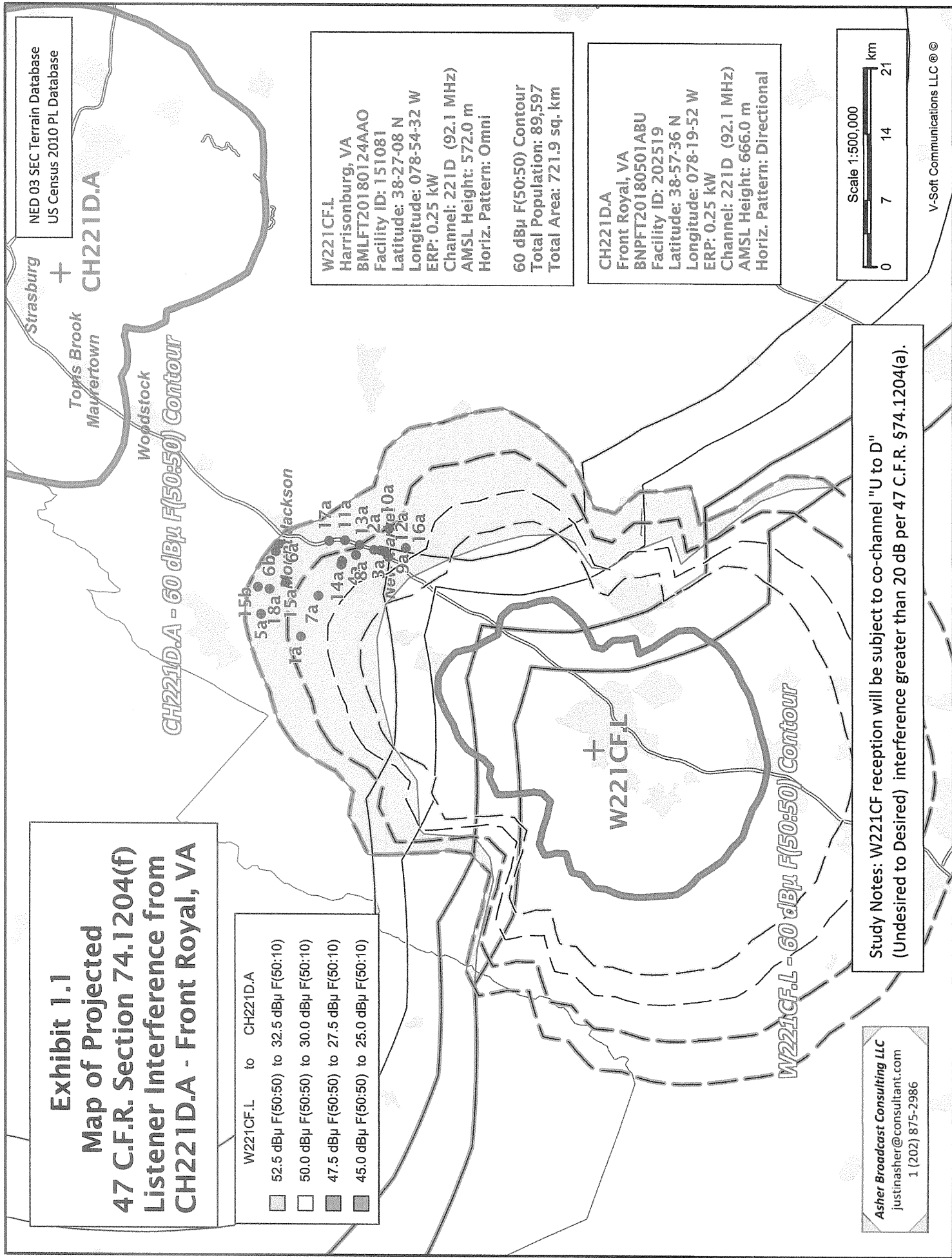
