Dear Ms. Dortch:

Red Wolf Broadcasting Corporation (“Red Wolf”), licensee of station WJJF(FM), Montauk, NY, replies to the Commission’s letter of September 30, 2019 (the “FCC Letter”). The FCC Letter requests that Red Wolf update the record in this proceeding to demonstrate that W235CN is still causing interference to WJJF(FM) under the FCC’s new FM translator interference rules.¹

Attached hereto as Attachment 1 are complaints from eight listeners of WJJF(FM) who state that they are still receiving interference from W235CN. These complaints are signed and dated and include each listener’s full name, address and phone number. They also contain (i) a clear, concise and accurate description of the location of the interference, (ii) a statement that the listener listens over-the-air at least twice a month, and (iii) a statement that the listener does not have any legal, financial, employment or familiar affiliation with WJJF(FM). Thus, these complaints comply with the requirements specified in the FM Translator Interference Order.

Attached hereto as Attachment 2 is the technical information requested in the FCC Letter. Red Wolf confirms that WJJF(FM) is operating with its licensed facilities. Red Wolf will reach out to Radio Sharon and use commercially reasonable efforts to attempt to resolve this interference matter.





This technical exhibit was prepared on behalf of Red Wolf Broadcasting Corporation (“Red Wolf”), licensee of FM station WJJF on channel 235A (94.9 MHz) at Montauk, New York (BLH-20120302AAX) in support of an Informal Objection and Interference Complaint to the application for license for W235CN on co-channel 235 (94.9 MHz) at Providence, Rhode Island (“W235CN”, FCC File No. BLFT-20171124AAA, Facility ID 41191). Specifically, the purpose of this technical exhibit is to demonstrate, pursuant to Section 74.1203(a)(3), that W235CN causes actual, actionable interference to the required number of regular WJJF listeners.

Under the recently adopted translator interference complaint procedures, the FCC established the 45 dBu contour as the limit within which interference complaints will be considered actionable, established a minimum number of listener complaints proportionate to the population served by the complaining station and adopted a contour-based U/D ratio method as a threshold causation test to establish that the complaining listener is within a “zone of potential interference”.¹

Station W235CN operates on channel 292 (94.9 MHz) which is co-channel to WJJF’s licensed operation also on channel 292A (94.9 MHz). Co-channel interference is predicted to occur if the U/D signal strength ratio exceeds -20 decibels (dB). Therefore, interference from W235CN within the WJJF 45 dBu contour was calculated based on a -20 dB U/D ratio using the FCC’s F(50,50) curves for determination of WJJF’s desired signal and the F(50,10) curves for determination of W235CN’s undesired signal. The resulting zone of predicted interference within WJJF’s 45 dBu contour from W235CN has been depicted on Figure 1 with yellow tinting.

It has been determined using the FCC's standard prediction method that the WJFF 60 dBu contour contains a 2010 Census population of 24,825 persons.² Therefore, based on Table 1 of Section 74.1203(a)(3), a minimum of six (6) listener complaints are required for an interference claim. Figure 2 provides a tabulation of seven (7) regular mobile and home WJFF listeners who submitted interference complaints and who receive interference within the zone of predicted interference depicted on Figure 1. The tabulation includes each listener's name, address, phone number and a description of where the interference occurs. The locations (i.e. route numbers, intersections, addresses, geographic coordinates, etc.) where each listener is receiving interference are identified on Figure 1.

As demonstrated above, W235CN causes actual, actionable interference to the required number of regular mobile and home/work WJFF listeners pursuant to Section 74.1203(a)(3).

I hereby declare under penalty of perjury that the forgoing is true and correct to the best of my personal knowledge and belief.



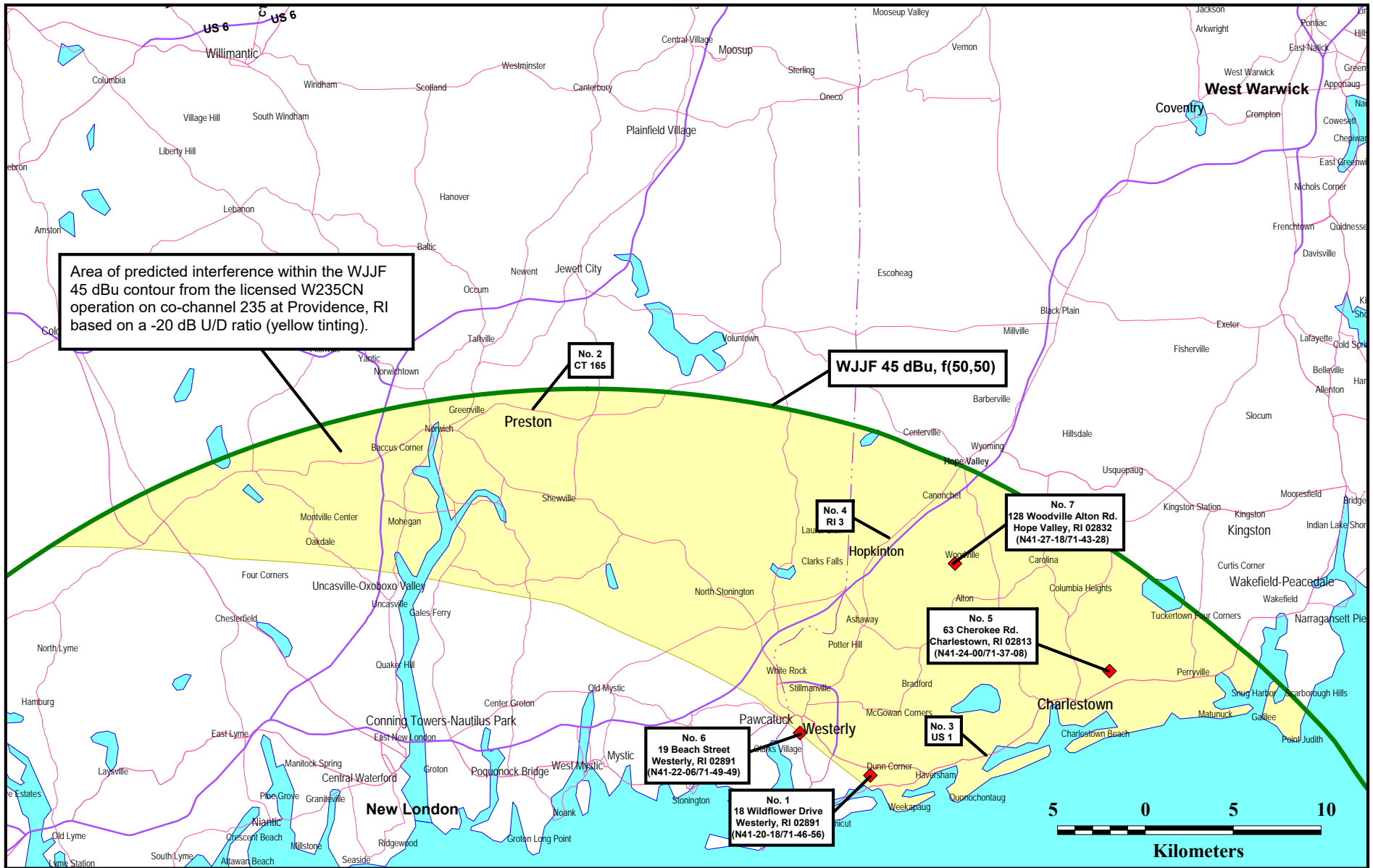
