**SUPPLEMENT TO
CONSOLIDATED OPPOSITION TO INFORMAL OBJECTIONS**

Bustos Media Holdings, LLC ("Bustos"), licensee of AM Broadcast Station KREH, Pecan Grove, Texas, and applicant for a construction permit for a new FM Translator Station at Houston, Texas to rebroadcast KREH, hereby respectfully submits this Supplement to its February 8, 2018 Consolidated Opposition to the Informal Objections electronically filed by B. J. Donalson, Jr. ("Donalson"), Claude B. Parker ("Parker") and Sergio Presa, Jr. ("Presa"). In so doing, the following is shown:

1. Section 73.5587 of the Commission's Rules does not put a time limit on oppositions to Informal Objections. Therefore, Bustos is filing this Supplement to provide additional engineering exhibits relative to the signal of FM Broadcast

Station KVST, Huntsville, Texas. Should leave to file this Supplement be required, the same is requested.

2. Bustos's technical consultant Kevin Youngers prepared a Longley Rice showing as to KVST's actual signal strength in the Houston metropolitan area. The first figure attached hereto shows the Longley Rice signal strength in relation to KVST's licensed normally protected contour. The second figure attached hereto shows an enlarged picture of KVST's signal strength in metropolitan Houston. Houston and Huntsville are approximately 70 miles apart via Interstate Highway 45. Not surprisingly, KVST has a signal strength between 20 and 40 dBu, well beneath a signal which the public can receive on conventional radios. The proposed Bustos translator on Channel 259 will have no effect upon the operations of KVST.

WHEREFORE, Bustos Media Holdings, LLC urges that: (1) the Informal Objections filed by B. J. Donalson, Jr., Claude B. Parker and Sergio Presa, Jr. **MUST BE DISMISSED OR DENIED**; (2) the above-captioned application of Bustos Media Holdings, LLC for a construction permit for a new FM Translator Station at Houston, Texas **BE GRANTED**.

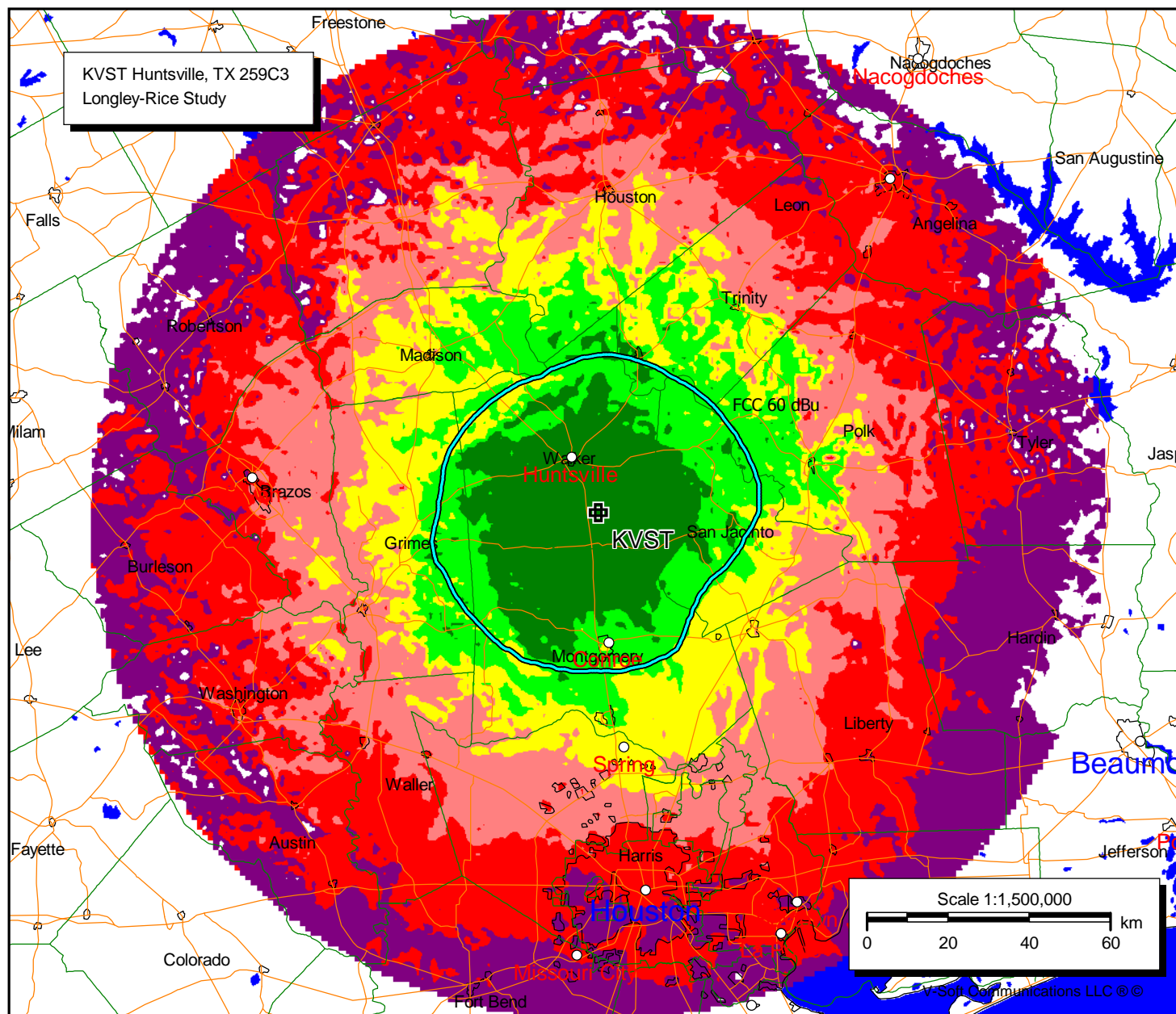

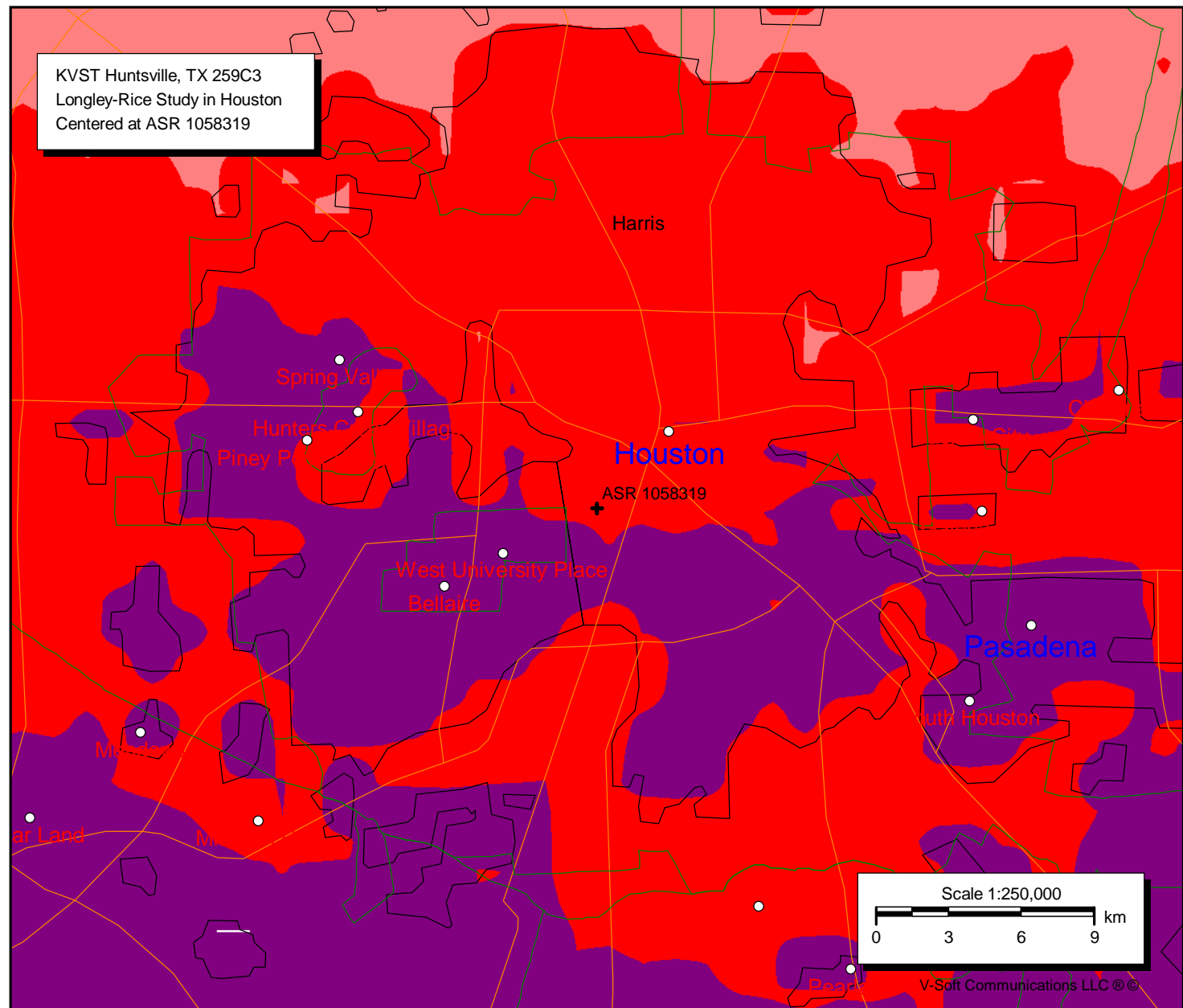
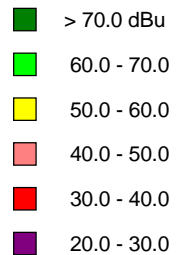
