PETITION FOR EXPEDITED RECONSIDERATION

Summit American, Inc. (“**Summit**”), licensee of Station KJUL (Channel 284C1), Moapa Valley, Nevada (Facility ID 63769), by its counsel, respectfully petitions the Audio Division, Media Bureau (the “**Division**”) to expeditiously reconsider its action granting the above-captioned application of Silver State Broadcasting, LLC (“**SSB**”) for a license (the “**License Application**”) to cover Construction Permit File No. BNPFT-20180502ACM for FM translator station K284CW, Winchester, Nevada (Facility ID 203222) (the “**Translator**” or “**K284CW**”).¹ Expedited reconsideration is warranted because the Translator’s operation is causing actionable interference to listeners’ reception of KJUL explicitly prohibited under §74.1203(b) of the Commission’s rules. The Division is thus urged to rescind its action granting the Translator license and direct SSB to immediately eliminate the interference that the Translator is causing to KJUL listeners’ reception. In support of this Petition, the following is shown:

I. Preliminary Statement

Section 1.106(b)(1) of the Commission's Rules allows any party whose interest will be adversely affected by an action taken by the Commission to file a petition for reconsideration of that action. As will be shown in detail herein, Summit's interests have been, and are continuing to be, adversely affected by the Division's grant of the License Application to SSB because the Translator's co-channel operation with KJUL is causing actionable interference to numerous KJUL regular listeners' reception of KJUL.

Section 1.106(b)(1) of the Rules also requires a petitioner, such as Summit, which did not protest the License Application while it was pending, to show good reason why it was not possible to do so. In this case, the Division granted the License Application six business days after placing it on public notice.² While the Division's processing efficiency may be commendable, Summit did not have adequate time to prepare and file an interference-based protest while the License Application was pending. Under similar circumstances, the Commission has accepted petitions for reconsideration when the grant of an application occurred shortly after the application was placed on public notice, finding that such expedient grant effectively precluded participation during the initial consideration of an application. *See, e.g., Anthony T. Lepore, Esq.*, Letter Order, 31 FCC Rcd 2217, 2219 (MB 2016). Summit should be treated no differently; this Petition should be considered on the merits because Summit has good reason for not participating during the Division's initial consideration of the License Application.

² Public notice of the License Application's acceptance for filing was issued in Report No. 29469, released Friday, April 19, 2019. The Division granted the License Application on Monday, April 29, 2019.

II. Showing of Actionable Interference

Summit acknowledges that the Commission recently modified its rules related to FM translator interference and that such modifications have not yet taken effect. *See Amendment of Part 74 of the Commission's Rules Regarding FM Translator*, Report and Order, MB Docket No. 18-119, released May 9, 2019. Accordingly, Summit herein provides ample evidence that K284CW is creating actionable interference under the Commission's Rules in their current form and as modified, but not yet in effect.

Submitted herewith is a Technical Statement prepared for Summit by consulting engineer Gene Wisniewski. Included with Mr. Wisniewski's Technical Statement at Attachment C are 18 statements provided by regular listeners of KJUL, all of whom are experiencing interference in their reception of KJUL's signal.³ As demonstrated in his Technical Statement and Attachment A thereto, Mr. Wisniewski has mapped the locations of the 18 listeners where interference to KJUL's signal has been received, confirming that all locations are inside the KJUL 45 dBu contour. Also, as shown in the Technical Statement and Attachment B thereto, Mr. Wisniewski has analyzed the signal strengths of KJUL and K284CW at the listeners' described locations, finding that at each location, the undesired to desired signal strength exceeds the -20 dBu threshold for co-channel interference. Accordingly, Mr. Wisniewski concludes that K284CW is

³ As defined in the recently adopted Section 74.1201(k) of the Rules, a listener complaint is a statement that is signed and dated by the listener and contains the following information: (1) the complainant's full name, address, and phone number; (2) a clear, concise, and accurate description of the location where interference is alleged or predicted to occur; (3) a statement that the complainant listens over-the-air to the desired station at least twice a month; and (4) a statement that the complainant has no legal, financial, employment, or familial affiliation or relationship with the desired station. All 18 listeners' statements submitted with this Petition meet these definitional requirements.

causing actionable co-channel interference to KJUL and should not be permitted to continue to operate as currently authorized.⁴

III. Conclusion

Mr. Wisniewski's Technical Statement and the Attachments thereto provide substantial, reliable evidence that the Translator's authorized operation is impermissible under §74.1203 of the Commission's Rules, as now in effect and as will be in effect. Summit therefore urges the Division to expeditiously reconsider its action granting the license for K284CW and return it to construction permit status, i.e. to File No. BNPFT-20180502ACM. Summit seeks expedited action by the Division in view of the current harm that the K284CW operation is causing to the KJUL listeners' interest in receiving an interference-free signal. By such expedited Division action, SSB will still have the opportunity to eliminate the interference that K284CW is causing to reception of KJUL, through the modification of its original construction permit or other measures.⁵ Thus, the remedy that Summit seeks here is fair and equitable to all concerned.

⁴ As noted by Mr. Wisniewski (Technical Statement Sec. III, para.4), the population within the protected 60 dBμ F(50,50) contour of KJUL is 29,181. Thus, by submitting 18 listeners' complaints, Summit has submitted three times the number of valid complaints (i.e., 6) that would be required if §74.1203 of the Rules, as modified, were currently in effect. Further, as would be required by §74.1203 of the Rules, as modified, Mr. Wisniewski has confirmed that KJUL is operating within its licensed parameters (Technical Statement Sec. III, para. 5).


⁵ Summit notes that SSB has a pending construction permit application (BPFT- 20190520AAZ) proposing a minor change to the licensed facility of K284CW. If the Division takes the proper course of action here to rescind the K284CW license, it should also dismiss SSB's pending application. Even so, out of an abundance of caution, Summit will file an informal objection to SSB's application demonstrating that proposed facility will cause, rather than eliminate, actionable interference to the reception of KJUL.

WHEREFORE, for good cause shown, expedited reconsideration of the action granting SSB's captioned application for license to cover the construction permit for K284CW is warranted, and the issued license should be rescinded.

Technical Statement

I. Introduction

This technical statement was prepared on behalf of Summit American, Inc. ("Summit"), licensee of KJUL (Channel 284C1), Moapa Valley, NV (Fac. ID 63769), in support of a Petition for Reconsideration of the action of the Audio Division, Media Bureau of the FCC that granted a license (File No. BLFT-20190415ABG) to Silver State Broadcasting LLC ("Silver State") for FM translator station K284CW, Winchester, NV (Fac. ID 203222).

II. Methodology

Summit presented a list of 54 individuals receiving interference to the reception of KJUL at home, work or while traveling in an automobile. The complaints listed hundreds of locations where interference was experienced. Complaints which lacked the necessary information to qualify as valid complaints (missing signature or phone number, or no clear indication whether interference was received) were discarded. The home addresses, work addresses and specific locations identified within the complaints where objectionable interference was received were plotted on a Google Earth map. All locations outside the 45 dB μ of KJUL were discarded. Twenty-five locations within the 45 dB μ contour of KJUL and within the 25 dB μ F(50,10) contour of K284CW were identified and analyzed. The signal strengths of KJUL and K284CW were determined at each of the 25 locations. The undesired to desired signal strength was calculated using the standard prediction methodology set out in §73.313 of the Commission's Rules. It was determined that the U/D signal strength at 18 locations exceeded the -20 dB μ threshold for co-channel interference. Many of the individuals identified multiple locations where interference was experienced; however, only one location per individual was considered in this analysis.

III. Supporting Data

1. **Attachment A** to this Statement is Map 1, a Google Earth map on which are plotted the 45 dB μ contour of Station KJUL and the 25 dB μ F(50,10) interfering contour of K284CW. Map 1 also identifies a specific location (residence, workplace or other location while traveling by automobile) where 18 listeners of KJUL have complained in writing that they have recently experienced interference to their reception of KJUL.
2. **Attachment B** is Table 1 which summarizes the pertinent data for each of the 18 complaints identified on Map 1. The Map ID on the Table refers to the numbered locations on Map 1. The name,

the location where the interference was experienced, the NAD83 coordinates, the signal strength of K284CW, the signal strength of KJUL and the U/D calculation are recorded for each location.

3. **Attachment C** hereto are copies of the 18 listeners' complaints that that Summit received from KJUL listeners, whose locations are plotted on Map 1 in **Attachment A** and summarized in Table 1 in **Attachment B**.

4. I have calculated the population within the protected 60 dB μ F(50,50) contour of KJUL to be **29,181** and hence only 6 valid complaints are required to demonstrate actionable interference under the Commission's recently modified rules concerning FM translator interference.


5. I have determined that KJUL is operating within its licensed parameters as authorized in license BLH-20041115ACG.

III. Conclusion

Having reviewed the attached listeners' complaints and the locations at which they experience interference in their reception of KJUL, it is my professional opinion that K284CW is causing actionable co-channel interference to KJUL, and therefore, in accordance with §73.1203 of the Commission's rules, K284CW should not be permitted to continue to operate as currently authorized; therefore, the license that was granted to Silver State for K284CW should be rescinded.

Further engineering analysis determined that there is no location to which the transmit location of K284CW can be moved via a Minor Modification application on channel 284 that will not result in actionable interference to the listeners of KJUL. To eliminate the interference to listeners of KJUL, K284CW must cease operations on channel 284 and move to another channel if such channel is available.

The undersigned, whose qualifications are a matter of record before the Commission, hereby declares, under penalty of perjury, that the foregoing statement was prepared by him and is true and correct to the best of his knowledge and belief.

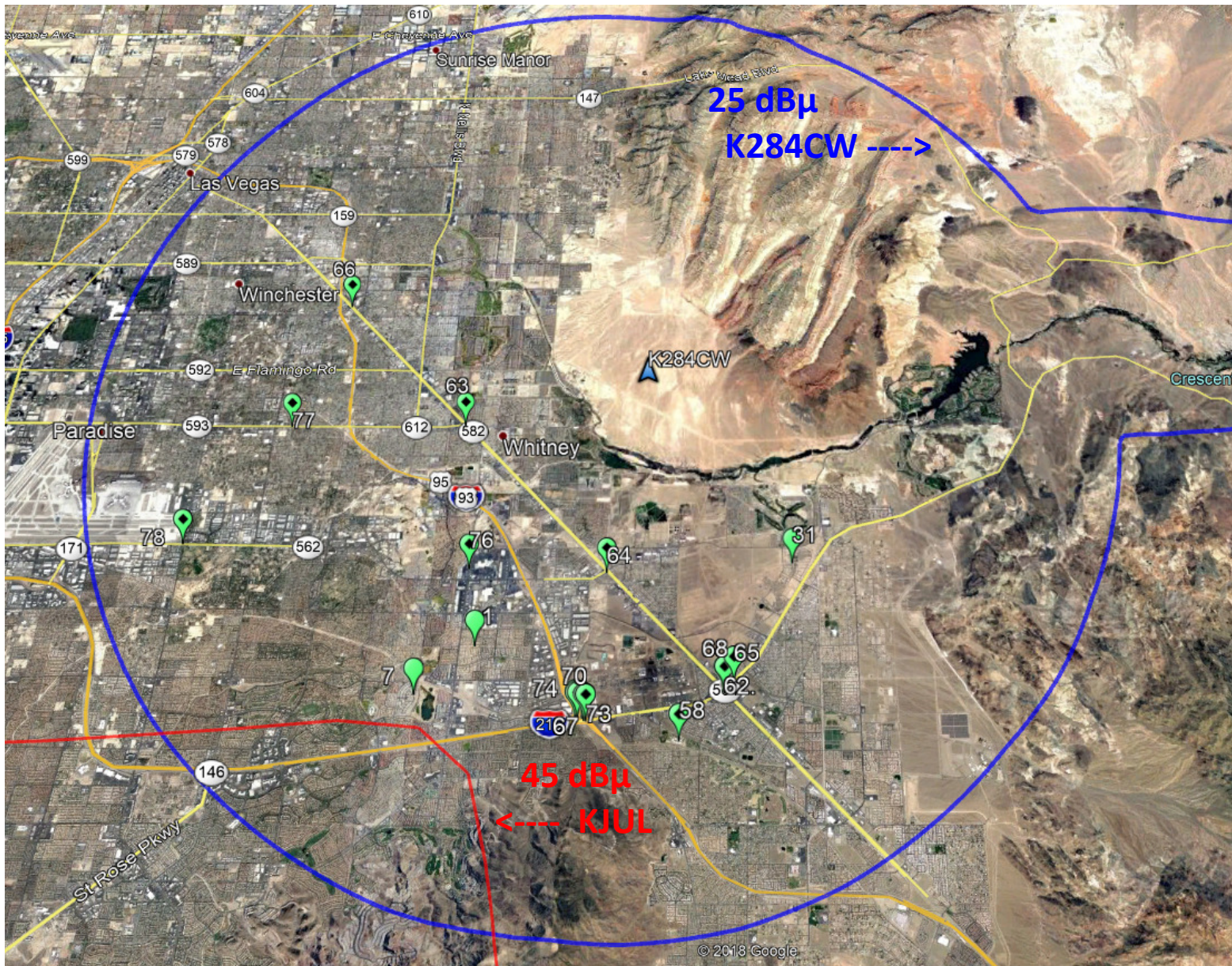


