RESPONSE TO “SUPPLEMENT TO PETITION TO DENY”

RedRock Radio Group LLC (“RedRock”), licensee of KBDX(FM), Blanding, Utah, and K256CA, Navajo Mountain/Lake Powell, Arizona, hereby submits its response to the Supplement to the Petition to Deny¹ filed on June 14, 2019, by Lake Powell Communications, Inc. (“LPC”), licensee of KXAX (FM), KPGE (AM), and K252FG, Page, Arizona. In support thereof, the following is shown:

RedRock will be filing with the Commission no later than July 12, 2019 an amendment to the above-captioned application and request for waiver to enable K256CA to serve an area that is unserved by full-service broadcast stations utilizing commonly owned station KBDX (which is located outside of the translator’s 60 dBu contour) as the translator station’s primary input station

¹ The caption “Petition to Deny” is a misnomer. Petitions to deny do not lie against minor modification applications. See, e.g., *Revision of Procedures Governing Amendments to FM Table of Allotments and Changes of Community of License in the Radio Broadcast Services, Report and Order, 21 FCC Rcd 14212, 14220,12 (2006)*. Section 73.2586 of the Commission’s rules (Procedure for Filing Informal Objections) provides that “[t]he limitation on pleadings and the time for filing pleadings provided by in Section 1.45 of the rules shall not be applicable to any objections duly filed under this section.”

transmitting with a proposed increased ERP of .250 kw. RedRock submits that the amendment will render moot the allegations asserted by LPC in its Supplement. A “service” copy of the amendment will be furnished to counsel for LPC.


