INFORMAL OBJECTION

1. Everett-Snohomish Broadcasting (hereafter “Everett-Snohomish”) licensee of FM station KMCQ, Oak Harbor, Washington (hereafter “KMCQ”) by its attorneys, pursuant to Sections 73.3587 and Sections 74.1203(a)(3) and 74.1203(b) of the Commission’s rules, hereby objects to a grant of the above captioned license application.

2. This license application is filed to cover construction permit BPFT-20170421AAM granted May 16, 2017 (the “CP”), the subject of unresolved interference complaints filed by Everett-Snohomish on June 19, 2017, seeking immediate remediation of the interference caused to its bona-fide listeners of the regularly-used co-channel KMCQ signal (the “Interference Complaint”). Everett-Snohomish hereby incorporates herein by reference the Interference Complaint and its exhibits. As shown in the Interference Complaint, Everett-Snohomish attempted to engage Entercom, licensee of K277AE, in cooperative efforts to resolve the interference issues, to no avail. Instead, Entercom, unilaterally filed the new CP, specifying no change of frequency and only a slight change of antenna pattern.

3. As stated in the Interference Complaint, the CP application made no mention of the interference K277AE was causing to KMCQ nor did it suggest the CP would provide

remediation for it. This was for good reason as the Interference Complaint provided studies that demonstrate that operation under the CP could not resolve the interference problem.

4. Despite these listener complaints and the engineering studies submitted by Everett-Snohomish, Entercom has apparently proceeded to build and has now filed the above-captioned application for license, the condition for operation under the CP. Therefore, K277AE must be presumed to be operating with its new facilities, despite the showing in the Interference Complaint that operation under this construction permit provides no remediation or relief for KMCQ. Accordingly, all of the allegations, engineering studies and interference complaints previously submitted with the Interference Complaint must be considered to be continuing and considered against the instant license application.

5. KMCQ continues to receive listener complaints of interference attributable to K277AE, the most recent of which is dated August 19, just two days before the K277AE license application was filed, and possibly while program tests had already begun with the new facility. Attached as Exhibit "A" are twelve new interference complaints from *bona fide* regular KMCQ listeners reporting interference from another radio station, described as co-channel 103.3 and as rap or hip-hop music. Those descriptions can only be a reference to K277AE. The full-power radio station associated with and being rebroadcast by K277AE is KHTP (FM). See Section 3A at BPFT-20170421AAM. KHTP, licensed to Tacoma Washington, identifies itself as "Hot 1037 Seattle" and programs hip hop style music. See Exhibit "B", a screen shot of the KHTP web site. Clearly, this is the music identified by the listener complaints. Furthermore, several of these new complaints come from areas that corroborate and reaffirm the areas of interference described in previous complainants against K277AE.

CONCLUSION

Considering the history of interference caused by K277AE to the regular listeners of KMCQ, Entercom's failure to remediate the past interference, the continuing receipt of new *bona fide* listener complaints from regular KMCQ listeners and the studies submitted with the Interference Complaint proving that K277AE operations under its new construction permit fail to provide any remediation to the interference, the instant license application should be rejected. Everett-Snohomish hereby requests that this application for license be denied and that pursuant to section 74.1203(b) of Commissions Rules, operation of K277AE be suspended and not resumed until it can be shown that the interference has been and will be eliminated into the future.
