

COURT APPOINTED RECEIVER JOSEPH BERNSTEIN'S
THIRD SUPPLEMENT TO OPPOSITION TO PETITION FOR RECONSIDERATION

Joseph Bernstein, duly appointed Receiver (“Receiver”) by the Philadelphia County Court of Common Pleas and Licensee of the above-captioned Low Power Television Station WFGD-LD, Philadelphia, Pennsylvania (the “Station”), by and through his attorneys pursuant to Section 1.106(b) of the Commission’s Rules, 47 C.F.R. § 1.106(b), hereby submits this Supplement (“Supplement”) in order to provide the Commission with important new information relevant to the FCC’s consideration of the Petition. On August 27, 2019, the Philadelphia County Court of Common Pleas entered two (2) Orders (attached hereto as Exhibits 1 and 2) *vacating* its January 22, 2019 order and *lifting* the Stay that the January 22, 2019 order had imposed in the case. In light of the vacating and lifting of the Stay against all matters in the proceeding, the Petition for Reconsideration should therefore be dismissed or denied.



AND NOW, to wit, this 27 day of August, 2019, upon consideration of the record and Plaintiff's foregoing Motion to Modify Stay to Allow Issuance of Writ of Execution on its Judgment Against Defendant Richard H. Glanton, ~~it appearing to the Court that Defendant Glanton is not an appellant in the appeal filed by Defendant PTN, and that Defendant Glanton has not otherwise taken any action to challenge Plaintiff's judgment in this matter, and it further appearing to the Court that Defendant PTN's rights would not be prejudiced by the relief requested by Plaintiff against Defendant Glanton,~~ it is hereby ORDERED, ADJUDGED AND DECREED, ~~consistent with Pa. R. A. P. 1701(b)(1) and 1701(c), that the Stay imposed by this Court's Order of January 22, 2019, is modified to exclude Defendant Richard H. Glanton from the provisions thereof, and it is further ORDERED that Plaintiff is free to issue writs of execution against Defendant Glanton only and/or to pursue other enforcement rights and remedies against Defendant Glanton only. All other provisions of this Court's stay order of January 22, 2019 remain in full force and effect.~~ that said motion is moot in light of this Court's August 27, 2019 Order vacating the Court's January 22, 2019 Order and lifting the Stay.
