**SECOND SUPPLEMENT TO INFORMAL OBJECTION;
PRELIMINARY REPLY TO OPPOSITION;
INITIAL REPLY TO ENTERCOM'S RESPONSE TO 30-DAY LETTER**

1. Everett-Snohomish Broadcasting (hereafter "Everett-Snohomish") licensee of FM station KMCQ, Oak Harbor, Washington (hereafter "KMCQ") by its attorneys, pursuant to Sections 74.1203(a)(3) and 74.1203(b) of the Commission's rules, hereby submits this second supplement to its informal objection to the grant of the above captioned license application filed August 23, 2017 by Entercom Licensee, LCC ("hereinafter "Entercom"), its initial reply to Entercom's Opposition to Informal Objection and response to the August 28, 2017, the Audio Division issued Entercom a 30-day letter.

2. In its opposition, Entercom has submitted an exhaustive response to the previously submitted interference complaints of KMCQ regular listeners together with an engineering analysis of tropospheric ducting it claims accounts for the intermittent listening of KMCQ listeners, challenging their status as "regular" listeners. Entercom also claims that the bulk of listener complaints are from concentrated areas where the KMCQ signal is too weak to be heard on a regular basis. Its engineering claims will require significant additional study and

engineering analysis Everett-Snohomish, which has begun and will be reported as soon as that project is completed.

3. Everett-Snohomish takes this opportunity, however, to again protest Entercom's unwillingness to work together to study this situation and the interference complaints of KMCQ's listeners. Had Entercom agreed to work together as Everett-Snohomish proposed, it is strongly believed that the parties would have been able to come to agreement on a number of the disputed technical issues and arrive at common conclusions leading to a concerted mutual effort to resolve the situation. Rather, it appears that the Entercom's strategy has been and remains to prolong and obfuscate proceeding by infusing it with technical allegations that will require multiple rounds of pleadings, delaying the opportunity to come to conclusions and through exhaustion of resources, succeed by exhausting its opponent. However, as revealed by this reply, every day that a conclusion is prolonged, more and more regular KMCQ listeners complain of interference from K277AE.

4. Entercom further complicates and confuses the situation by claiming that Everett-Snohomish stopped communicating with them. That allegation glosses over and misrepresents the situation with sleight-of-hand. As previously submitted, Everett-Snohomish made numerous offers to Entercom for a mutual effort to investigate and resolve the situation, having secured the cooperation of KMAS, which has a translator on the same frequency, so there would be no co-channel interference while mapping the KMCQ signal, and offering to conduct these tests at night. Everett-Snohomish remains open to that plan, and invites Entercom to cooperate on as night where the tropospheric conditions are not expected to be a factor. With information obtained from such testing, Everett-Snohomish is hopeful that the parties can determine an antenna/power design that will prevent K277AE from interfering with KMCQ.

5. However each prior offer of cooperation was rebuffed. Entercom then sought copies of listener complaints to investigate on its own. Everett-Snohomish chose instead to file the complaints with the Commission as an alternative way to formalize the conflict and effect the provision of the complaints to Entercom.

6. Entercom's plans appear to have worked, drawing out the proceeding while additional interference complaints are received, many of which specifically mention K277AE by its retransmitted signal, frequency, format description or in other ways.

7. Everett-Snohomish submits herewith an additional 37 complaints of interference from its regular listeners received in the last month. Admittedly, a number of the complaints identify the interference only as "scratchy or noisy" or "another radio station at 103.3FM." Some may be legitimately confused with another station. However, ten listeners specifically mention 103.7 by name, some referring to the interfering station as KHTP-FM at 103.7, K277AE's retransmitted station. Ten of them specifically identify the station as 103.7, hip hop, R&B rap music, hip hop music and so. For example, one listener specifically identifies the interference as:

"KHTP-FM at 103.7 which is rap (crap!) and they are bleeding from their assigned frequency 103.7 all the way down to yours at 103.3. So now I cannot get your station at all here" at Tukwila. (Apparently unaware that KHTP at 103.3 is retransmitted by K277AE at 103.3).

8. Combined with prior submissions, there are now a total of 97 complaints of interference, many of which specifically identify K277AE as KHTP, by format, as another radio station at 103.3 or station bleeding down from 103.7.

9. In *Letter to Arohi Media LLC*¹ Ahohi Media was ordered to discontinue operations because two *bona fide* listener complaints to co-channel WLUS-FM, Clarksville, VA had not been addressed. Specifically, the letter states: “Accordingly, when the Commission concludes that a bona fide listener has made an actionable complaint of uncorrected interference from an FM translator, it will notify the station that “interference is being caused” and direct the station to discontinue operations.”

10. Entercom’s response is a poor attempt to obfuscate the situation and claim it has remediated all the complaints of interference. In fact, it has remediated none of them. And now we have 37 more complaints of interference that it must investigate and remediate.

11. The August 28, 2017, Entercom a 30-day letter directed it to “resolve all complaints of interference to fulfill its obligations” and stated specifically that “[f]ailure to correct all complaints within this time may require K277AE to suspend operation pursuant to 47 CFR § 74.1203.” Entercom failed to meet this burden. While some might be ascribed to another station or weak signal, Entercom clearly has not resolved all interference complaints. Rather it has thrown up unproven engineering inferences in a wild attempt to shift the burden to Everett-Snohomish.

12. As previously stated, Everett-Snohomish is in the process of undertaking an independent engineering analysis to rebut and disprove many of Entercom’s allegations. Meanwhile, Everett-Snohomish renews its offer to work together, rather than in conflict, to investigate and resolve the interference problems in a mutually satisfactory way. For now, however, the Commission is justified to conclude that bona fide listeners have made actionable



complaints of uncorrected interference from K277AE and that K277AE must now suspend operations until each of the complainants who respond to Entercom are satisfactorily remediated.

13. According, Everett-Snohomish again requests that the application for license be denied and that, pursuant to §74.1203(b) of the Commission's Rules, Entercom be ordered immediately to suspend operation of K277AE unless and until it can be shown to a reasonable degree of certainty that each complaint of interference from a cooperating complainant has been remediated to that listener's satisfaction.
